U.T. ADMINISTRATION OF DAMAN & DIU ACHIEVEMENTS & ACTIVITIES UNDER MAJOR DEVELOPMENTAL SCHEMES

(For the month of June2015)

The Union Territory Administration is committed towards providing an inclusive development to the population residing in the territory. A number of schemes for creation and upgradation of physical infrastructure and towards improving the socio-economic status of the citizens are being implemented by the U.T. Administration. The progress in this regard during the month of June, 2015 is highlighted below.

A. <u>Progress under Infrastructural Developmental Works :</u>

(i) Major Works completed during the month of June, 2015:

- Development of parking area near Gangeshwar Temple at Fudam Diu has been completed at a cost of **Rs. 44,00,000**.
- Widening and recarpeting of road from complain center to Krishna park divider at Fudam Diu has been completed at a cost of **Rs. 35,00,000**.
- Raising of compound wall of airport from parking to opposite Hokka hotel at Nagoa, Diu has been completed at a cost of **Rs. 9,26,000**.
- Diversion of existing 66KV D/C Una-Diu Transmission line to nearby area at Dangerwadi village in Diu.

B. <u>Progress under Individual beneficiaries Oriented Schemes during</u> <u>the month of June, 2015:</u>

A number of schemes for the benefit of individuals are being implemented by the Administration, in which assistance in cash/kind is being provided by way of scholarship, pension, subsidy, loan, advances etc. The progress in this regard in various sectors during the month of June, 2015 is as follows:
