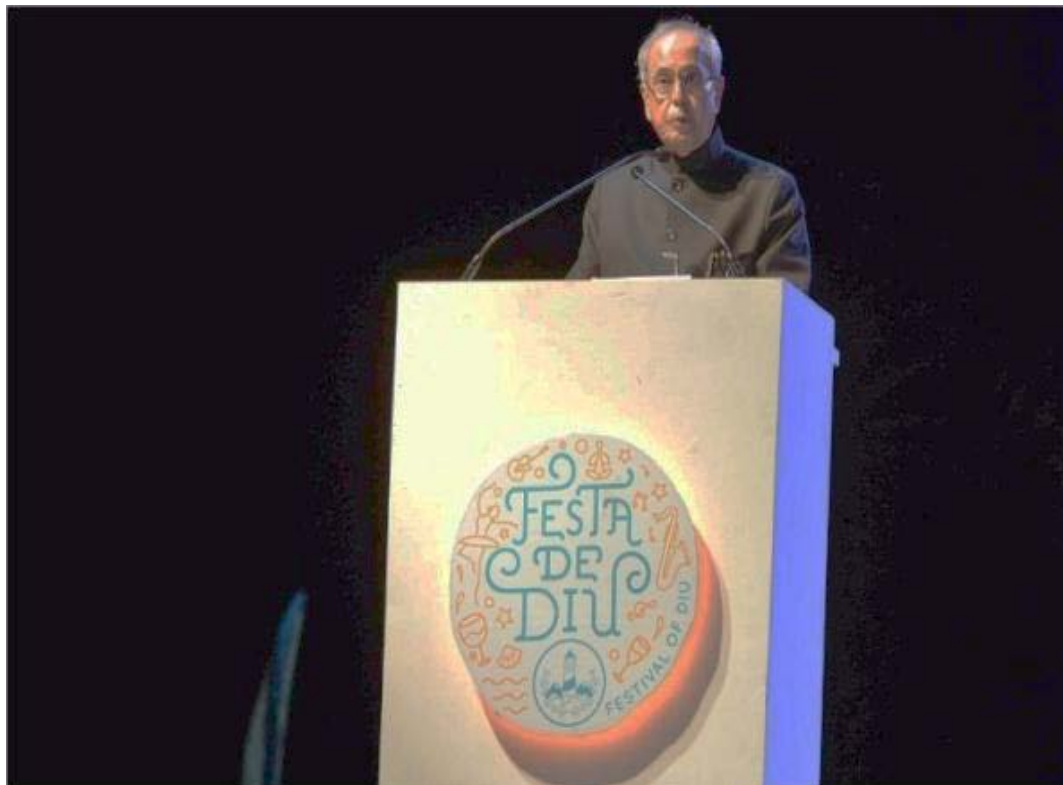

The Union Territory is committed towards providing an inclusive development to the population residing in the territory. A number of schemes for creation and upgradation of physical infrastructure and towards improving the socio-economic status of the citizens are being implemented by the U.T. Administration. The progress in this regard during the month of December, 2015 is highlighted below.

A. Progress under Infrastructural Developmental Works :

(i) New Major Works started during the month of December, 2015:

- Foundation Stone for Construction of **Government College and site development of Education Hub** at Kevdi, Diu at a cost of Rs. 47.98 Crore was laid by **Hon'ble Administrator**, on 24th December, 2015.
- Foundation Stone for Construction of bridge across **Damanganga River connecting Kachigam on Nani Daman side and Zari on Moti Daman side** at a cost of Rs. 39.5 Crore was laid by **Hon'ble Administrator** in the presence of **Hon'ble Member of Parliament** on 19th December, 2015.
- Foundation Stone for Construction of **Girls Hostel at Government College**, Daman was laid by **Hon'ble Administrator** in presence of **Hon'ble Member of Parliament** on 19th December, 2015.

(ii) Major Works completed during the month of December, 2015:

- The Hon'ble Administrator of U.T. of Daman & Diu has inaugurated the Parallel Bridge at Ghoghla, Diu on 24th December, 2015. The work has been completed at a cost of Rs. 36 Crore.
- **Vidyut Bhavan** has been inaugurated by the Hon'ble Administrator, U.T. of Daman & Diu & other dignitaries on 19th December, 2015 in presence of Hon'ble Member of Parliament. The construction work of this building was completed at a cost of Rs 6.43 Crore.
- **Udyog Bhavan** has been inaugurated by the Hon'ble Administrator, U.T. of Daman & Diu in presence of Hon'ble Member of Parliament & other dignitaries on 19th December, 2015. The Construction work of this building was completed at a cost of Rs 4.51 Crore.

- **Art Faculty at Government College Campus**, Daman has been inaugurated by the Hon'ble Administrator, U.T. of Daman & Diu & other dignitaries on 19th December, 2015 in presence of Hon'ble Member of Parliament. The Construction work of this building was completed at a cost of Rs 4.47 crore.
- **LekhaBhavan** has been inaugurated by the Hon'ble Administrator, U.T. of Daman & Diu & other dignitaries on 19th December, 2015 in presence of Hon'ble Member of Parliament. The Construction work of this building was completed at a cost of Rs 4.15 Crore.
- Providing and fixing of false **ceiling, acoustics, flooring carpet and chair sitting arrangement of the auditorium** near overhead tank at malala village, diu was completed at the cost of Rs. 1.99 Crore on 10th December, 2015.
- Construction of **asphalt road** with **Hume pipe gutter** from sweeper's quarters to Mangelwadadjacent to protection wall in ward No. 6 at Moti Daman was completed at the cost of Rs. 1.11 Crore.
- Construction of **compound wall** over bridge for parking area and new works for the auditorium near overhead water tank at Malala village was completed at a cost of Rs. 1.09 crore on 25th December, 2015.
- Supplying, installing and **commissioning** the special sound system & electronic project system for auditorium at Malala, Diu was completed at the cost of Rs. 51 lakh on 25th December, 2015.
- Providing and erecting of **fire system** for the auditorium near water tank at Malala at diu was completed at a cost of Rs. 50 lakh on 15th December, 2015.

B. Progress under Individual beneficiaries Oriented Schemes during the month of December, 2015:

A number of schemes for the benefit of individuals are being implemented by the Administration, in which assistance in cash/kind is being provided by way of scholarship, pension, subsidy, loan, advances etc. The progress in this regard in various sectors during the month of December, 2015 is as follows:

➤ **ICDS**

- Provided **nutritious food** to **6113** Children (06 months to 06 years).
- Provided **Food grain** to **1588** pregnant women & lactating / nursing Mothers.
- Provided **nutritious food** to **1359** Adolescent Girls – School Going.
- Provided **nutritious food** to **158** Adolescent Girls – Out of School.

➤ **Development of SC/ST/OBC**

- Financial Assistance for Self Employment on service oriented units was released to 30 beneficiaries under Tribal Sub Plan and amount of Rs. 3.43 Lakh were disbursed to the youths.
- Top-Up Scholarship amount of Rs. 314.23 Lakh was released to 3350 beneficiaries.
- Cash award of Rs. 27 Lakh was released to 540 meritorious SC/ST girl students.

➤ **Rural / Urban Development**

- Pension released to **8642 Old Age** pensioners, **Widow** Pensioners and **Disabled** pensioners under National Social Assistance Programme.

➤ **Health**

- Financial assistance released to 67 beneficiaries under Janani Suraksha Yojana.

➤ **Crop Husbandry**

- Tractors facility has been provided to **01 farmer** on subsidy for Agriculture operations.

➤ **Agriculture**

- Two days training programme was organized on Mushroom Cultivation Technology to 45 farmers.

C. Organisation of important Events during the month of December, 2015:

- 3 Days Daman Mohatsava/ Beach Festival has been organized by the Tourism Department from 28th to 31st December, 2015. A Carnival was also organized on the occasion.
- The Hon'ble Administrator, U.T. of Daman & Diu has reviewed the progress of various schemes of District Panchayats in the Conference Hall, Daman on 9th December, 2015.
- The Collector, Daman has reviewed the progress of various schemes of Sansad Gram VikasYojana on 3rd December, 2015.
- Finance Secretary & Secretary (Planning) visited Diu on 14th December, 2015 and reviewed the program status of various infrastructural development projects with Government officers and Public Representatives.
- The Collector, Daman visited village panchayat Patlara for monitoring of ongoing developmental works & for identifications of new developmental projects with Sarpanch, Panchayat Members, District Panchayat President, Chief Executive Officer, etc.

➤ Health

- World AIDS Day was observed by Health Department on 1st December, 2015. State Aids Control Society & Non-Government organization of both district of Daman & Diu organized AIDS awareness rally, debate competition, seminar, poster exhibition on the occassion.
- ANMs, BHWs, health supervisors link workers were trained for carrying out diseases surveillance activity under Integrated Disease Surveillance program of U.T. of Daman & Diu.

➤ Education

- A 5 day training program on Environmental Building program (IEDSS) for teachers under RMSA was organized on 15th December, 2015 in which

they were sensitized about how to make proper environment for differently abled children/students.

- A workshop/seminar on Stress Management was organized by the Social Welfare Department on 17th December, 2015. About 500 students were benefited by this workshop.
- Health Checkup camp was organized at Daman in which health checkup of differently abled students was done by the expert doctors on 23rd December, 2015 under RMSA.

➤ **Agriculture**

- Farmer Training Program & distribution of seedling were done by the agriculture department. The District Panchayat President Shri Suresh Patel was present in the function.

➤ **Bal Bhavan**

- The U.T. of Daman & Diu has celebrated its 55th Liberation Day on 19th December, 2015. On the occasion various artist of WZCC (Udaipur) had performed various cultural programme.
- On the occasion of Christmas the Bal Bhavan Board, daman has organized gift wrapping, rangoli, mehendi, best out of waste, talent hunt (Singing & Dancing)programme for the Bal Bhavan Students.

➤ **Sports**

- Half Marathon race was organized by the Sports Department of Daman & Diu on 20th December, 2015. The District Collector & Hon'ble Member of Parliament had flagged off the race. About 2200 people had participated in the event.
- The Inter School Tennis Cricket Tournament for Under 17 boys was organized.

- **UT Level Chess Tournament/Selection Camp– 2015** was organized on 29th & 30th December, 2015 at Daman in which players of U-14, 17 & 19 (Boys & Girls) were selected for participation in 61st National School Games.
- **Daman & Diu Karate Team** has participated in 61st National School Games held at Jabalpur, Madhya Pradesh from 7th to 11th December – 2015.
- **Daman & Diu Tug of War team** has participated in 61st National School Games held at Taluka Sports Complex, Malkapur, Maharashtra from 15th to 17th December – 2015.
