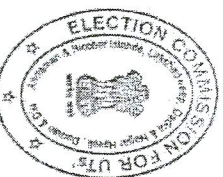

NOTIFICATION

No. 7-2/EC/DD/2017 Whereas casual vacancies have occurred in Ward No. 4/8 of Bucharwada Gram Panchayat and Ward of 6/8 of Zolawadi Gram Panchayat in Diu District of the Union Territory of Daman and Diu due to resignation of members, as shown in the Annex to this notification.

Now, therefore, in pursuance of the provisions of Rule 114 of the Daman and Diu Panchayats (Election Procedure) Rules, 2014, the Election Commission for Daman & Diu, appointed under Section 185 of the Andaman and Nicobar Islands (Panchayats) Regulation, 1994, hereby calls upon the said wards to elect a member each to fill the said vacancies in accordance with the provisions of the Daman & Diu Panchayats Regulation, 2012 and the said Rules and Orders made thereunder and appoints the following dates with respect to the said bye election. Ward No. 6/8 of Zolawadi Gram Panchayat is reserved for general women.

- (a) the 6th December, 2017 (Wednesday) between 11.00 a.m. and 3.00 p.m., as the last date and hours for making nominations;
- (b) the 7th December, 2017 (Thursday) 11.00 a.m., office of the Returning Officer as the date, time and place for scrutiny of nominations;
- (c) the 8th December, 2017 (Saturday) 3.00 p.m., as the last date and hour for the withdrawal of candidatures;
- (d) the 23rd December, 2017 (Saturday) between 8.00 a.m. and 5.00 p.m., as the date on which and the hours during which the poll shall, if necessary, be taken and
- (e) the 27th December, 2017 (Wednesday) as the date before which the election shall be completed.
