Subject- Seventh Central Pay Commission's recommendations – revision of pay scales – amendment of Service Rules/ Recruitment Rules.

The undersigned is directed to refer to DoPT's OM No AB.14017/13/2016-Estt.(RR) dated 9th August 2016 (copy enclosed) and to point out that in view of the D/o Expenditure notification dated 25th July 2016 notifying the CCS (RP) rules, 2016 the existing service rules/RRs need to be amended by substituting the existing Pay Band and Grade Pay by the new pay structure i.e. LEVEL in the PAY MATRIX by the respective cadre controlling authorities straightaway without making a reference to DOPT/UPSC.

2. A review meeting for assessing the progress in amendment of RRs was taken by JS(R) in DoPT on 20.10.2016 wherein it was desired that the matter may be expedited so as to complete the process by 30.11.2016.

3. It is therefore requested that the exercise for amendments of RRs may please be undertaken on a priority basis and the progress report as on 31.10.2016 may please sent to this ministry so that the same may be intimated to DoPT.

The undersigned is directed to refer to the Office Memorandum of even number dated 9.8.2015 on the above mentioned subject wherein it was requested that as per the CCS (Revised Pay) Rules 2016 issued by Department of Expenditure vide Notification dated 25th July, 2016, consequential amendment in the existing Service Rules/Recruitment Rules shall be made by the Ministries/Departments by substituting the existing Pay Band and Grade Pay by the new pay structure i.e. "LEVEL in the PAY MATRIX" straightaway without making a reference to the Department of Personnel and Training (DOP&T)/Union Public Service Commission (UPSC).
