

Sub: Delegation of powers to Lieutenant Governors and Administrators of Union Territories to accord cadre clearance and vigilance clearance to officers working in respective Union Territories for personal or official visits abroad for a period not exceeding three weeks - reg.

Sir,

DoPT vide their letters No.11019/6/2001-AIS-III dated 07.03.2003 and 05.12.2007, delegated to State Governments and Ministries/Departments of Govt. of India powers to sanction cadre and vigilance clearance to All India Service officers for personal or official visits abroad. Governments of Arunachal Pradesh, Mizoram and Goa being State Governments are covered by said letters of DoPT dated 07.03.2003 and 05.02.2007.

2. Ministry of Home Affairs, functioning as State Government in respect of officers posted in Union Territories has been according cadre and vigilance clearance to the officers posted in Union Territories for personal or official visits abroad in accordance with the above delegation by DoPT.

3. The Competent Authority in the Ministry of Home Affairs, has approved the following delegation of powers with immediate effect and until further orders:

- (i) To LGs/Administrators of UTs to accord cadre clearance to the officers working in the respective Union Territories for personal/official visits abroad for a period not exceeding three weeks.
- (ii) To LGs/Administrators of UTs to accord vigilance clearance to the officers working in the respective Union Territories for personal/official visits abroad for a period not exceeding three weeks based on the quarterly vigilance status provided by Ministry of Home Affairs.

4. The aforesaid delegation of powers is confined to the cases where there is no departure from the extant Rules and instructions contained in DoPT's letter No.11019/6/2001-AIS.III dated 05.12.2007. A copy of DoPT's letter dated 05.12.2007 is enclosed.

5. In all the cases where there is departure from the extant rules and/or instructions etc., on the subject necessitating relaxation, the case shall be submitted to the Ministry of Home Affairs as per the procedure.
