- 1. The rate(s) quoted should be strictly for delivery of the Marine VHF/Wireless Base Station for use of the Office of the Supdt. of Fisheries, Daman. No extra charges for installation, packing, forwarding and insurance etc. shall be paid on the rates quoted.
- 2. The articles mentioned in this tender will have to be supply within a week from the date of receipt of order at F.O.R. i.e. Office of the Supdt. of Fisheries, Daman.
- 3. The rates should be quoted inclusive of all taxes.
- 4. The rates should be quoted only in this Schedule. However, the Tenderer may quote in their printed letter pad duly stamp and signed and should enclose this Notice duly sign with stamp with tender paper.
- The successful bidder/tenderer has to establish Base Station in the Office of the Supdt. of Fisheries, Daman and obtain/supply a Base Station operating License for Marine VHF & AIS from the Govt. of India, Ministry of Communication, WPCwing, New Delhi.
- 6. The rates quoted should remain valid and operative for a period of 60 days from the date of tender.
- 7. The rates should be quoted only for the items specified in the schedule and should be for the items of given specifications/mark/manufacturer. As for as possible illustrated leaflets/catalogue should be enclosed with the tender. Where specification/mark manufacturer are not specified. Rates quoted should be only for the Standard quality. The decision of the undersigned for equivalent, specification standard quality etc. of the article shall be final.
- 8. The items, which are not found according to specification given in the tender or satisfactorily, will be rejected and it will have to be replaced at supplier's own cost.
