

BICYCLE FOR GIRLS UNDER SSA SCHEMES.**



- 1) The rate(s) quoted should be strictly for free delivery at the school in Daman District.
- 2) The rate should be quoted inclusive of all taxes including Service Tax/Vat etc.
- 3) Except C.S.T. all other taxes/duties payable on the sale/transport etc within and or outside the state of the supplier shall be payable by the supplier only.
- 4) No extra charge for packing, forwarding and insurance etc. will be paid.
- 5) In case of failure to supply of any item as per the condition and within the stipulated time the same will be awarded to the next second lowest and the loss to the Govt. on this account shall be recovered from the former suppliers, security deposit/earnest money.
- 6) Tenderer should supply the material as per Configuration & description mentioned in the tender form only.
- 7) Where specification/mark manufactures are not specified by this office the rate should be quoted for ISI approved products of standard quality.
- 8) The Tenderer should send in advance or enclose along with tender an amount of Rs. 20,000/- (Rupees Twenty Thousand only) as Earnest Money Deposit in form of Demand Draft / F.D.R. of any scheduled Bank payable at Daman in favor of the officer inviting tenders i.e. Secretary, Sarva Shiksha Abhiyan Society, Daman. The E.M.D. submitted other than form mentioned above will not be accepted. Tender received without Earnest Money Deposit will be summarily rejected.
- 9) The suppliers will have to supply the materials/goods/articles/items to the various govt. schools of Daman District at their own cost as per list issued by the Asstt. Director of Education, Secretary (SSA), District Panchayat, Moti Daman.
- 10) All bills should be in duplicate and invariably mention the numbers and date of the tender and supply order of the Secretary, SSA Society UT of Daman & Diu Daman.
- 11) All bills for amount above Rs.5000/- should be pre-receipted on a Revenue Stamp of proper value. Bills for amount exceeding Rs.5000/- not pre-receipted on Revenue Stamp of proper value will not be accepted for payment.
- 12) Each bill in which sales tax is charged must contain certificate on the body of the bill.

"CERTIFIED that the goods on which Sales Tax has been charged have not been exempted under the Central Sale Tax Act or the Rules made there under and the amount charged on account of Sales Tax on these goods is not more than what is payable under the provisions of relevant Act or Rules made there under".
- 13) The tender should be neatly typed only on letterhead carry which the name of supplier and the signature of the tenderer. No overwriting, correction or erasures will be considered.
- 14) The right to accept or reject without assigning any reasons any or all tenders in part or whole is reserved with the Tender Inviting Officer and his decision(s) on all matters relating to acceptance or rejection of the tenders as a whole or in part will be final and binding to all.
- 15) In case, the supplier does not execute the supply order placed with him, the EMD of the supplier will be forfeited to the Government and the contract for the supply shall terminated with no further liabilities on either party to the contract.

- 16) The tender will be accepted during working hours up to 12/09/2011 at 13:00 hrs. and opened on same day at 15:00 hrs. If possible in the office of the Asstt. Director of Education, Secretary (SSA), District Panchayat, Moti Daman in the presence of the Tender Committee and tenderer(s) or their representative(s) if present.
- 17) The amount of earnest money paid by the tenderer, whose tender is not acceptable, will be refunded to them.
- 18) No. separate agreement will be required to be signed by the successful tenderer(s) for the purpose of the contract for supply rates tendered/offered in responses to the concerned tender/notice shall be considered as acceptance of all above terms and conditions for supply for all legal purposes.
- 19) No advance payment will be made. Payment to Contractor/s shall be made by A/C payees crossed cheque.
- 20) The configuration & specification in original duly signed by the contractor/supplier is to be attached with tender documents.
