Tender form will be issued only to those who produce the following Certificates/Documents along with application.

1. Valid Income Tax Clearance Certificate with copies of returns for last 3 years.
2. Sales Tax/Vat Registration Certificate.
3. The bidder should be dealing in the items for which he is filing tender.
4. The bidder should submit the proof of annual turnover of Rs. 25,00,000.00 and above per annum for Sports / Gym equipments for the last three years.
5. In case, there is a small scale industry, there should be a proof of registration.

The eligible tenderer should submit the offer to the Head of Sports, Moti Daman by subscribing “**Purchase of Gym Equipments for Padmabhushan Sports Complex at Diu**” on the envelope enclosing his/her rate and also enclosing EMD of Rs. 53,000/-.

The last date of receipt of tender is **18.02.2011** at **4.00** p.m. at Office of the Head of Sports, Moti Daman and the same will be opened on the same day at **05.00** p.m. if possible. **** Terms and Conditions for Supply and installation of Gym equipments & other Sports material at Diu.**

Sealed tender is hereby invited on behalf of the President of India by the Head of Sports Department, Daman for supply of Gym equipments as per Annexure – I attached from the reputed brands for the use of Sports Department., Diu with the following conditions:

1) Eligibility :

- (a) The bidder should be registered under Sales Tax/VAT.
 - (b) The bidder should be manufacturer/authorized dealer/supplier of the items tendered for, from last three years.
- 2) The Earnest Money Deposit (E.M.D) of Rs. 53,000.00 is payable with the tender in form of Demand Draft issued by the Scheduled Bank in favour of **Head of Sports, Daman.** Tender received without EMD will be treated as invalid.**

3) Completed tender form should contain the following documents/certificates:

- Income Tax Clearance Certificate along with copies of returns of last three years.
 - Sales Tax / VAT Registration Certificate for the tendered items.
 - Proof of manufacturing/dealership/supplier for three years of the items tendered for.
 - In case, there is a small scale industry, there should be a proof of registration.
 - Details of nature of constitution of their firm / names & addresses of the proprietor / partners / directors and also the details of sister concerns if any.
 - EMD in form of Demand Draft.
- 4) The bidder should submit the proof of annual turnover of Rs. 25,00,000.00 and above per annum for Sports / Gym equipments for the last three years. The tender received without or below annual turnover of Rs. 25,00,000.00 will not be accepted.**
- 5) The tender should be in a sealed envelope subscribed as “ **Purchase of Gym Equipments for Padmabhushan Sports Complex** ”.**

- 6) The Tender Form along with Terms and Conditions can be obtained from the Office of the Office of the Head of Sports, Moti Daman. Tender notice is also available at website www.daman.nic.in.
- 7) The rate(s) quoted should be strictly for free delivery at F.O.R **Diu**. No extra charge for packaging, forwarding and insurance, transportation etc. will be paid.
- 8) Only Sales Tax / VAT will be paid on the items on which it is chargeable under the Central Sales Tax Act / VAT Act or the Rules made there under.
- 9) **Two Bid Systems** : The bidder should ensure that they submit the Bid in two separate sealed covers each super scribed “ Technical & Financial Bid”.
- 10) (A) **Technical Bid Cover** : Technical bid consisting of all technical details.

DOCUMENTS TO BE SUBMITTED ALONGWITH TECHNICAL BID:

- (i) Tender fee in form of Demand Draft of requisite amount in favour of Head of Sports, Daman.
- (ii) Vetted/Self certificate Performance Reports.
- (iii) All documents mentioned in Para 3, above.
- (iv) Copy of Terms & Conditions of tender duly signed by the bidder.
- (v) The EMD cover should contain EMD amount in form of demand draft as mentioned in the tender. The name of the Bank must be mentioned on cover itself. It may be noted that the offer without EMD will not be accepted and the Technical Bid cover will not be opened.
- (vi) Compliance to technical specification:-

The Compliance statement should be submitted in the following formats :

(B) **Financial Bid Cover** : Financial Bid indicating item wise price for the items mentioned in the bid. The Technical bid and the financial bid should be sealed by the bidder in separate covers duly super scribed and both these sealed covers are to be put in a bigger cover which should also be sealed and duly super scribed. The technical bids are to be opened by the tender committee at the first instance and evaluated by a competent committee. At the second stage, financial bids of only the technically acceptable offers will be opened for further evaluation and ranking before awarding the contract.

- 11)** The rate(s) should be quoted only for the items specified in the list of requirement and should be for the items of given special make / manufacture.
- 12)** Rate(s) quoted for items other than the required specification/make/manufacture may not be considered. However, indigenous manufacturers may quote their own makes provided the specifications confirm to the standard(s) / requirements of the given specification/make/manufacturer.
- 13)** The Office of the Head of Sports, Daman will be at liberty to accept the tender for the entire quantity or the part thereof at the rates submitted by the bidder or at reduced rate during the negotiations if any.
- 14)** Where specification/make/Manufacture is not specified by this office, the rate(s) should be quoted only for the standard quality.
- 15)** The tenderer should specify the name of the manufacturer for the items quoted by him along with catalogue of the items.
- 16)** The tender should be neatly typed carrying the name of supplier and the signature of the tenderer. No overwriting, correction or erasing will be considered.
- 17)** Items supplied by the successful tenderer shall be randomly checked & verified by the Tender inviting Officer through Departmental staff/authorized staff. Acceptance item shall be strictly subject to satisfaction of the verifying authority. The item which are not found as per specification given in the tender will be directly rejected and the same has to be replaced by the cost of the tenderer.
- 18)** Payment shall be made only after acceptance of items and verification by the authority.
- 19)** The amount of Earnest Money Deposit paid by the Tenderer(s) whose tenders are not accepted will be refunded to them within 03 days.
- 20)** Successful bidder will have to sign an agreement with the purchaser within 3 working days of the receipt of the supply order.
- 21)** Rates tendered/offered in response to the concerned Tender Notice by the successful bidder shall be considered as acceptance of all the terms and conditions for supply for all legal purpose.
- 22)** The successful bidder will have to pay an amount equal to 10% of the total value of the supply order within 10 days from the date of the order as Security Deposit in form of Demand Draft in favour of Head of Sports, Moti Daman for the duration of one year.
- 23)** Non – receipt of Security Deposit within stipulated time limit will result in automatic cancellation of the order for supply without any intimation.

- 24) In case, the supplier does not execute the supply order placed with him, the Security Deposit of the Supplier will be forfeited to the Govt. and the contract for the supply shall be terminated with no further liabilities on either party to the contract.
- 25) The items/materials specified in the tender should be supplied at the site of the **Padmabhushan Sports Complex, Diu** only and installed the same in the Complex with the cost of suppliers.
- 26) The Tender will be received upto 4.00 p.m. on **18.02.2011** in the office of the Head of Sports, Moti Daman. The tender will be opened at 05.00 p.m on the same day if possible.
- 27) The supply and installation should be executed within 15 days from the date of supply order, failing which EMD will be forfeited.
- 28) All bills should be in DUPLICATE and should invariably mention the number and date of supply order.
- 29) All bills for amount above Rs. 5,000.00 should be pre-receipted on a Revenue Stamp of proper value. Bills for amount exceeding Rs. 5,000.00 not pre-receipted on Revenue Stamp of proper value will not accept for payment.
- 30) Each bill in which VAT is charged must contain the following certificate on the body of the bill.
“CERTIFICATE that the goods on which Value Added Tax has been charged have not been exempted under the Central Sale Tax Act or the Rules made there under and the amount charged on account of Value Added Tax on these goods is not more than what is payable under the provisions of relevant Act or Rules made there under.”
- 31) In respect of any dispute given rise to the legal proceedings between the parties, the courts at Daman shall alone have the Jurisdiction.
