## NOTICE INVITING TENDERS FOR HARVESTING/ SALE OF CHIKOO FRUITS

Tenders are hereby invited from the interested parties up to 12:00 Hrs on 14/09/2012 for harvesting/ sale of chikoo fruits from trees in the Govt. Seed Multiplication Farm, Kachigam, during the period w.e.f. 01/10/2012 to 30/06/2013, subject to terms & conditions given below:

## **TERMS AND CONDITIONS:-**

- 1. The upset price for the bid is Rs. 83,000/-. The intended Tenderers are required to bid above the upset price.
- 2. The tenders shall be given on plain paper and submitted in the name of Zonal Agriculture Officer, Daman in a sealed cover super scribed as "Tenders for Sale of Chikoo Fruits".
- 3. The intended Tenderer is required to deposit an amount of Rs. 2075/- in the form of FDR/Demand Draft drawn in favour of the Zonal Agriculture Officer, Daman along with the tenders as "Earnest Money Deposit". Failing which, the tenders will not be accepted.
- 4. The tenders will be opened on 14/09/2012 at 05:00 PM in presence of the Members of the Committee constituted for the purpose and the Tenderers or their representatives, if any.
- 5. The highest Tenderer shall be the "successful Tenderer". The successful Tenderer shall have to deposit tender amount with Zonal Agriculture Officer, Daman on or before the date of taking over of the possession of the orchard/ trees. Failing which, his tender will be treated as "cancelled" and his EMD will be forfeited to the Government.
- 6. The successful Tenderer shall have to deposit a Security Deposit of Rs. 4150/-, by seven days from the date of award of tender, in the form of FDR or otherwise drawn in the name of the Zonal Agriculture Officer, Daman which will be valid up to at least one year from 29/09/2013. Failing which, his tender will be treated as "cancelled" and his EMD will be forfeited to the Government.
- 7. The EMD of the unsuccessful Tenderer will be released within one month from the date of opening of tenders. The EMD of the successful Tenderer will be released within two months from the date of opening of tenders.
- 8. The Security Deposit of the successful Tenderer will be released only after 30/06/2013, however, within twelve months from 01/10/2012 after deducting dues payable to the Government, if any.
- 9. The successful Tenderer shall have to deposit an amount of Rs. 4150/-, towards "Performance Guarantee", in the form of FDR or otherwise drawn in the name of the Zonal Agriculture Officer, Daman, which will be valid up to at least one year from 20/09/2013, within ten days from taking over of the possession of the Chikoo Orchard.
- 10. The amount deposited against Performance Guarantee will be released only after successful completion of tenure granted to such Tenderer for harvesting of Chikoo Fruits after deducting dues payable to the Government, if any.

- 11. The Chikoo Orchard is open for the inspection by the intended person(s) between 10:00 Hrs to 17:00 Hrs on any working day, however, with prior permission of the I/c of Govt. Seed Multiplication Farm, Kachigam. The I/c of Govt. Seed Multiplication Farm, Kachigam has authority to deny such permission for the reasons not to be explained to the interested person (s).
- 12. After taking over the possession of the trees in the orchard, the successful Tenderer shall make the proper inventory showing the details, including the health status, of trees and obtain countersignature of the I/c of Govt. Seed Multiplication Farm, Kachigam.
- 13. No any kind of damage shall be caused to the trees and other property of the Farm. In case of any such damage, the successful Tenderer has to compensate the same as per instructions of the I/c of Govt. Seed Multiplication Farm, Kachigam. Failing which, the Tenderer will not be allowed to continue the harvesting of Chikoo Fruits. The Government shall not be responsible for the damages occurred to the Tenderer on account of such discontinuation of harvesting. If required, his Security Deposit and Performance Guarantee lying with the department will also be forfeited to the Government in order to recover the losses caused to Government.
- 14. The harvesting/ grading/ transportation/ sale of fruits is allowed on all working days during working hours till 30/06/2013 at the responsibility & cost of successful Tenderer.
- 15. Assigning of any tree or trees in the orchard to other parties, by any mean, by the successful Tenderer is not allowed under any circumstances.
- 16. All maintenance operations of the orchard will be carried out by the department at its own costs.
- 17. The right to accept or to reject any or all tenders, without assigning any reason thereof, is reserved with the Zonal Agriculture Officer, Daman.
