

**TERMS AND CODITION:**

1. The interested bidder shall have to deposit an amount Rs. 5,5000/- to become eligible to participate in the auction.
2. The bid will start from the upset price as shown in the auction notice.
3. The eligible participant shall have to offer the bid in the denomination of Rs. 2,000/- above the upset price.
4. An offer will be considered as highest and final only if the amount offered by the bidder is announced subsequently three times uninterrupted.
5. The successful highest bidder will have to deposit entire bid within 15 days from the date of acceptance of higher bid as mention in the bid acceptance letter.
6. The successful highest bidder will have to lift the vehicle within 15 days from the date of acceptance of higher bid as mention in the bid acceptance letter. The said vehicle will be allowed to lift only after receipt of entire higher bid amount only.
7. In case of failure of the highest bidder to deposit the entire amount within the specified period, his deposit against his eligibility to participate in the auction will stand forfeited to the Government.
8. In case of the failure of the highest bidder (s) to lift the vehicle within the specified period the amount @ Rs.1000/- per day will be levied as a rental for parking/security of vehicle.
