## Terms & Conditions:

- 1. The interested parties should quote their offer/ rates on their letter head or plain paper with their signature & seal. Prior making an offer, the interested parties are advised to inspect the existing conditions of the Green/ Shed Net Houses to be maintained.
- 2. The interested parties should have experience in the field of setting up, operation & repair of Green/ Shed Net Houses.
- The maintenance work is to be done till 31st March, 2013. The offered rates should be inclusive all taxes & valid up to 31st March, 2013.
- The maintenance work includes repairs/ replacement to structural parts/ plastic sheets/ shed net/ fittings, formation/ alteration/ addition/ deletion of planting beds along with planting medium and repairs/ replacement of spares of irrigation system, as required or as may be directed from time to time. The Successful Tenderer shall have to bear all the costs on maintenance including repairs & replacement of material/ tools/equipments/ spare parts/ labour, etc.

- 6. The materials/ tools/ equipments/ spare parts, etc. to be replaced should conform to the specification given by the department. The materials/ tools/ equipments/ spare parts, etc. which are not conforming to the given specification will be rejected and the Successful Tenderer shall have to replace the same within specified period of time.
- The interested parties, along with their Tender, must enclose an EMD, as described above, in the form of valid FD/ DD drawn in the name of Zonal Agriculture Officer, Daman. The Tender received without the prescribed EMD shall be rejected. The EMDs of the unsuccessful Tenderer will be returned to them within 30 days from opening of the Tenders.
