

**The terms & condition for applicable are as under:**

- 1 The interested parties should quote their offer/ rates on letter-head under their signature & seal along with Tender form.
- 2 The rates should be inclusive of all taxes & valid up to 180 days from the date of opening of the Tender .
- 3 The interested parties should have the above mentioned items ready in their stock for supply. The delivery of F O R is to be made at Govt. Horticulture Farm, Moti Daman.
- 4 The items to be supplied should have been produced/ manufactured, packed, labelled and being sold in conformity with the provisions of relevant Acts/ Rules in force.
- 5 To examine the credentials, the random sampling of the items will be done in accordance with the norms as assigned under the Fertilizer Control Order 1985. The items found defective or damaged or otherwise not conforming to the given specifications will be rejected and the supplier will be liable to replace the same within specified period.
- 6 The quantity to be supplied will be subject to replacement without prior notice.
- 7 The EMD should be furnished in the form of Demand Draft drawn in favour of **Chief Executive Officer, District Panchayat, Daman & Diu, Daman** and the same should be enclosed with sealed Tender document. Tender received without specified EMD shall be summarily rejected.
- 8 Taxes/cess/surcharges as applicable, will be deducted from the final payment of the Supplier as per provision of rule of Act/Rules.
- 9 The interested party should submit the copies of Income Tax Returns filed by them for the last two Assessment years alongwith copy of PAN.
- 10 Interested parties should be registered with VAT Deptt. of State /UT in which its HO/Sale office is located and should submit the copy of VAT Registration Certificate/TIN.
- 11 The payment will be made through crossed cheque only after successful completion of supply to the satisfaction of the undersigned.
- 12 The Tender forms are available upto 21/09/2012 and may be obtained after payment of Rs.500/- (Rs. Five Hundred) during working hours on any working day from Agriculture Section, District Panchayat, Dholar, Moti Daman, Daman .
