Last dated for receipt of limited tenders in the office of Statistical Officer, TSP Cell, Collectorate, Daman is **02/07/2012 (up to 3.00 p.m)** and will be opened on **03/07/2012 at 4.00 p.m.** if possible in the office of the Statistical Officer, TSP Cell, Moti Daman in the presence of the purchase committee and renderer(s) or their representative(s) if present.

The Tenderer should send along with tender by as Earnest Money deposit equivalent to 2.5% of total tendered value in the form of deposit at Call Receipt/Fixed Deposit Receipt drawn on the State Bank of India or any other scheduled Bank of Daman IN favour of the Statistical Officer, TSP Cell, Daman. The rate should be inclusive of transportation charges and all taxes for supply of food grains, pulses, oil, grocery items ect. To the Ashramshalas every quarter. Sample of all items except specified brand should be sent alongwith tender,. Supply order will be issued quarterly.
