Sealed are hereby invited from the interested parties up to 12:00 Hrs on 01/06/2012 for harvesting/ sale of Mango fruits from trees in the Govt. Horticulture Farm, Fort area, Moti Daman during harvesting season 2012-13, subject to terms & conditions given below:

# **TERMS AND CONDITIONS :-**

- 1 The upset price for the tender is **Rs. 35,800**/-. The intended tenders are required to quote the rates above upset price.
- 2 The tender shall be given full address with mobile No. on plain paper under their signature and submitted in the name of Chief Executive Officer, District Panchayat, Daman in a sealed cover super scribed as "Tender for Sale of Mango Fruits".
- 3 The intended tenders is required to deposit an amount of **Rs. 1000/-** in the form of FDR/ Demand Draft drawn in favor of the <u>Chief Executive Officer, District Panchayat,Daman</u> along with the tender as "Earnest Money Deposit". Failing which, the tender will not be accepted.

- 7 The Mango Orchard is open for the inspection by the intended Tenderer (s) between 10:00 Hrs to 17:00 Hrs on any working day, however, with prior permission of the I/c of Horticulture Farm, Fort area, Moti Daman . The I/c of Horticulture Farm, Fort area, Moti Daman has authority to deny such permission for the reasons not to be explained to the intended Tenderer (s).
- 8 No any kind of damage shall be caused to the trees and other property of the Farm during harvesting and post-harvest operations. In case of any such damage, the successful tenders has to compensate the same as per instructions of the I/c of Horticulture Farm, Fort area, Moti Daman . Failing which, the tenders will not be allowed to continue the harvesting of Mango Fruits. The Government shall not be responsible for the damages occurred to the tenders on account of such discontinuation of harvesting.
