
LIMITED TENDER NOTICE

Sealed tender is hereby invited on behalf of the U.T. Administration of Daman & Diu for **Hiring of water tanker for watering road divider plantation from Bamanpuja up to Dholar Char Rasta** as per details given below.:

The condition for supply are as under :-

1. The supplier should quote their rates on their own letter pad OR on plain paper with their rubber stamp. Rate should be quoted per unit.
2. The tender received without EMD in the form of DD shall be rejected. DD shall be accepted only if it is valid for six month (180 days) or more after the last date of receipt of tender. The DD shall be drawn in the favour of the Deputy Conservator of Forest, Daman.
3. The rates for the above items should be inclusive all taxes & quoted for FOR at Moti Daman, Daman.
4. The rates should quoted by the firm who are able to supply/provide materials from licensed outlets on receipt of the clear supply order from this Department.
5. The tendered should mention clearly the make & model with catalog/literature of the items quoted.
6. The supply should be completed within prescribed time limit given by the Department.
7. The material found defective or damaged or otherwise not as per given specification shall be rejected. The firm should replace the same otherwise payment will not be made.
8. The payment will be made after full supply of material and at the satisfaction of this Department.
9. Income Tax will be deducted as per the I.T. Rules.
10. The sealed Quotation should reach this office upto 12.00 noon on **31/10/2012** in sealed envelop superscribed as "**Limited Tender Notice for Hiring of water tanker for watering road divider plantation from Bamanpuja up to Dholar Char Rasta**" and it will be opened on the same day in presence of bidders or their representatives, if possible.
11. The rates should be valid upto 31st March 2013.
12. Right to reject or accept any or all Tender is reserved with undersigned.
13. All the disputes subject to the jurisdiction of court in the Union Territory of Daman & Diu.
