

Terms & Conditions:-

- 1 The interested parties should quote their offer/ rates on their letter head or plain paper with their signature & seal. Prior making an offer, the interested parties are advised to inspect the whole tractor with implements at Govt. Horticulture Farm, Moti Daman..
- 2 The interested parties should have at least three years experience in the field of machinery work.
- 3 The offered rates should be inclusive all taxes & valid up to 31st March, 2013.
- 4 All the materials used for the work should be of standard quality. If the materials of sub-standard quality are used, the same will be rejected and the Successful Tenderer shall have to replace the same within specified period of time.
- 5 The EMD, if demanded, shall be furnished in the form of valid FDR or DD drawn in the name of Chief Executive Officer, District Panchayat, Daman & Diu, Daman and the same should be enclosed with sealed tender. Tender received without enclosing specified EMD, if demanded, shall be rejected. EMD of the Successful Tenderer will be retained till Sixty days from 31st March, 2013. The EMDs of the unsuccessful Tenderers will be released to them within 30 days from the date of opening of Tenders.
- 6 If the Successful Tenderer fails to fulfil his obligations as per terms and conditions of the Tender Notice and Work Order issued thereupon, his EMD, Security Deposit & Performance Guarantee shall be forfeited to the Government. The Department shall also have the privilege to use all such ways & means to protect the interest of the Government.
- 7 The payment will be made direct bank accounts only after successful completion of supply to the satisfaction of the Chief Executive officer, Dist. Panchayat Daman.
- 8 The sealed tender should reach this office up to 3.00 p.m. on p.m. on 28/11/2012 in the sealed envelope superscribed as "**Tender for Repair & replacement of parts for tractor**". 
