NOTICE INVITING TENDERS FOR HARVESTING/ SALE OF MANGO FRUITS

Tenders are hereby invited from the interested parties up to 12:00 Hrs on 07/05/2013 for harvesting/ sale of Mango fruits from trees in the Govt. Seed Multiplication Farm, Kachigam, during harvesting season 2013-14, subject to terms & conditions given below:

TERMS AND CONDITIONS :-

1. The upset price for the bid is Rs. 44,000/-. The intended Tenderers are required to bid above the upset price.
2. The tenders shall be given on plain paper and submitted in the name of Zonal Agriculture Officer, Daman in a sealed cover super scribed as "Tenders for Sale of Mango Fruits".
3. The intended Tenderer is required to deposit an amount of Rs. 1000/- in the form of FDR/ Demand Draft drawn in favour of the Zonal Agriculture Officer, Daman along with the tenders as "Earnest Money Deposit". Failing which, the tenders will not be accepted.
4. The tenders will be opened on 07/05/2013 at 05:00 PM in presence of the Members of the Committee constituted for the purpose and the Tenderers or their representatives, if any.
5. The highest Tenderer shall be the "successful Tenderer". The successful Tenderer shall have to deposit tender amount with Zonal Agriculture Officer, Daman on or before the date of taking over of the possession of the orchard/ trees. Failing which, his tender will be treated as "cancelled" and his EMD will be forfeited to the Government.
6. The EMD of the unsuccessful Tenderer will be released within one month from the date of opening of tenders. The EMD of the successful Tenderer will be released within two months from the date of opening of tenders.
7. The Mango Orchard is open for the inspection by the intended person(s) between 10:00 Hrs to 17:00 Hrs on any working day, however, with prior permission of the I/c of Govt. Seed Multiplication Farm, Kachigam. The I/c of Govt. Seed Multiplication Farm, Kachigam has authority to deny such permission for the reasons not to be explained to the interested Tenderer (s).
8. No any kind of damage shall be caused to the trees and other property of the Farm. In case of any such damage, the successful Tenderer has to compensate the same as per instructions of the I/c of Govt. Seed Multiplication Farm, Kachigam. Failing which, the Tenderer will not be allowed to continue the harvesting of Mango Fruits. The Government shall not be responsible for the damages occurred to the Tenderer on account of such discontinuation of harvesting. If required, his EMD lying with the department will also be forfeited to the Government in order to recover the losses occurred to Government.
9. The harvesting/ grading/ transportation/ sale of fruits is allowed on all working days during working hours till the end of harvest season at the responsibility & cost of successful Tenderer.

10. Assigning of any tree or trees in the orchard to other parties, by any mean, by the successful Tenderer is not allowed under any circumstances.
11. The right to accept or to reject any or all tenders, without assigning any reason thereof, is reserved with the Zonal Agriculture Officer, Daman.
