- 4. The work includes repairs to existing system, replacement of damaged & unserviceable machinery/parts. Also includes installing suitable Micro- Irrigation Systems in various demonstration plots, nurseries, etc. in the Farm.
- All the materials used for the work should be of standard quality. If the materials of sub- standard quality are used, the same will be rejected and the successful tenderer shall have to replace the same within specified period of time.

- 7. The successful Tenderer shall have to pay the Security Deposit & Performance Guarantee to the extent of 5% of the Cost of Tender in each case.
