

Horticulture Farm, Moti Daman. within 15 days, from the date of issue of date of supply Order. The Successful Tenderer shall have to bear all the costs on R.O, Water cooler with installation work including transportation/material/ labour, etc.
- The Water cooler ISI mark etc. to be supplied should have been produced/ manufactured, labelled and being sold in conformity with the provisions of relevant Acts/ Rules in force.
- To examine the credentials, the random sampling of the items will be done in accordance with established norms. The items found defective or damaged or otherwise not conforming to the given specifications will be rejected and the supplier will be liable to replace the same within specified period of time in within 15 days.
- The quantity to be supplied will be subject to replacement without prior notice.
- Taxes/cess/surcharges as applicable, will be deducted from the final payment of the Supplier as per provision of rule of Act/Rules.
- The payment will be made through direct bank accounts only after successful completion of supply to the satisfaction Chief Executive Officer, District panchayat, Daman & Diu, Daman.
