NOTICE INVITING TENDERS FOR SALE OF PADDY

Sealed tenders are hereby invited from the interested parties up to 12:00 Hrs on 28/06/2011 for sale of different below mentioned varieties of paddy harvested during kharif 2012 from the Govt. Seed Multiplication Farm, Kachigam subject to terms & conditions given below:

TERMS AND CONDITIONS :-

1. Paddy can be inspected by the intending Tenderers during office hours till 12:00 A.M. on 28/06/2013.
2. The tender shall be given on plain paper and submitted in the name of Zonal Agriculture Officer, Daman in a sealed envelope super scribed as "Tender for Sale of Paddy".
3. The intended Tenderer is required to deposit an amount of Rs. 700/- in the form of FDR/ Demand Draft drawn in favour of the Zonal Agriculture Officer, Daman along with the Tender as "Earnest Money Deposit". Failing which, the Tender will not be accepted.
4. The Tenders will be opened on 28/06/2013 at 05:00 PM in presence of the Members of the Committee constituted for the purpose and the Tenderers or their representatives, if any.

5. The highest Tenderer shall be the "successful Tenderer". The successful Tenderer shall have to deposit Tender amount i.e. value of the paddy with Zonal Agriculture Officer, Daman within a week from the date of communication received from the Department of Agriculture, Daman. Failing which, his Tender will be treated as "cancelled" and his EMD will be forfeited to the Government.
6. The EMD of the unsuccessful Tenderer will be released within one month from the date of opening of Tenders. The EMD of the successful Tenderers will stand converted into Security Deposit and will be released within one month from the date of depositing value of paddy, after deducting dues payable to the Government, if any.
7. The successful Tenderer should lift the paddy from the farm within ten days from the date of depositing value of the paddy at his own cost & responsibility.
8. The right to accept or to reject any or all Tenders, without assigning any reason thereof, is reserved with the Zonal Agriculture Officer, Daman.
