The experience certificate of last three years or list of work in hand carried out by the Firm / Registered Contractor will have to be produced by the Contractor dully certified by the Competent Authority who is applying for the Tender Form along with (i) The No Dues Certificate from the VAT Department with copy of VAT Registration Certificate in terms of Order No.VAT/DMC/2004-05/245 dated 26.07.2006 and (ii) copy of Income Tax Returns for last 3 years. (iii) Registration under Building and Other Construction Work (RE&CS) Act, 1996 in terms of letter No.LE/LI/DMN/REC-30(1)/2010-870 dated 26.02.2010.

Earnest Money Deposit be deposited along with the application seeking issue of Tender Document in Deposit at Call Receipt of Scheduled Bank / Fixed Deposit Receipt of Scheduled Bank (Single FDR shall be accepted only if it is valid for 6 months, 365 days or more after the last date of receipt of tender) issued in favour of the Chief Officer, Daman Municipal Council, Daman.

Tender Forms duly filled along with copy of Registration Certificate under VAT, Labour Department, Income Tax Department etc. to be submitted in DMC office failing which the tender shall be summarily rejected.

The Tenderer should fulfill all the criteria / condition of CPWD failing which tender will be rejected summarily.
