

Proposal Details

Introduction

Government Hospital at Nani Daman, was started in the year pre-liberation time (before 1962) with a minimum OPD services and Indoor facility. This hospital later on equipped with enhanced OPD & Indoor Patient facilities, whereas most of the departments are equipped with modern technology & equipments. The hospital has a group of dedicated doctors, medical and paramedical staff. The Hospital consists of following facilities.

- The Hospital is having 135 bed IPD facility.
- The Hospital is having 12 bed facilities in ICU, The ICU is equipped with ventilators, Defibrillator and Multipara Monitor etc.
- Patients of CVA, AGE, IHD, RHD, Diabetic, Fever, Poisoning, Snakebite, TB, Tetanus, Rabies, Meningitis and any other epidemic or communicable diseases are treated. The IPD of hospital is having below described departments to take care of different diseases.

Reason of renovation of existing Operation Theatres

Presently the existing OTs are based on conventional technology & standards prior used in Hospitals, hence need to be equipped with modern technologies which are currently imbibe by modern super specialty hospitals all over the world in current era. The conventional structure can't deliver the expected positive results since the latest equipments need to be incorporated in the same. The Government of India itself constitutes a regulatory body with the name of National Accreditation Board for Hospitals & Healthcare Providers- "NABH", "NABH" itself recommends to implement modern technology operation theatres equipped with Laminar Air Flow system with other component & equipments and the same imposed statutory need of minimal health hazards of SSI(Surgical site Infections). The Modern Technology benefits all stake holders. Patients are the biggest beneficiary. The Modular OT system results in high quality of care and patient safety. The patients get services by credential medical facilities available for treatments. Patient safety & satisfaction is regularly evaluated.

Implementation of modern state of art Modular Operation Theatre stimulates continuous improvement. It enables the hospital in demonstrating commitment to quality patient care. It raises community confidence in the health services provided by the health care organization. It also provides opportunity to healthcare unit to benchmark with the best. Finally, Operation Theatre equipped with modern technology provides an objective system of empanelment by insurance and other third parties.

Scope of Work

Medical Superintendent, Government Hospital, Nani Daman, India, has invited this Expression of Interest(EOI) for the Design, Fixing & installation, Commissioning and maintenance of 4(Four) nos. of Modular Operation Theatres in Government Hospital, Devka Beach Road, Nani Daman, India, The four nos. of OTs and the VIP Room, Recovery room in the OT Block established on the ground floor of the above mentioned hospital building.

Interested Vendors are required to submit the following documents including the questionnaire as detailed herein complete in all respects with one original, two authenticated copies and the soft copy in MS Word on a CD for the following:

Instruction to Applicants

1. One copy of the documents/questionnaires shall be marked as "Original" and other one copy as "copy". In case of any discrepancy between the ORIGINAL and the COPY, the information contained in the 'ORIGINAL' shall govern. These shall be sealed in an envelope and submitted to the addressee on or before the last time and the date specified elsewhere in the document. The envelope shall be super scribed as "Application for Pre-qualification for Supply and installation of Modular Operation Theatre" for Government Hospital Nani Daman and shall show the name(s) and address of the applicant(s) clearly.
2. Interested Vendors are required to submit all the documents as mentioned herein including the concept note duly completed in all respects with one original, one authenticated copy and the soft copy in MS Word on a CD.
3. The Bidder/applicant shall enclose latest brochures/catalogue (Original) and technical documentation of products.
4. Each page shall be duly signed by the applicant or his authorized representative.
5. The EOI with required document shall be submitted on or before to the Office of the Medical Superintendent, Government Hospital Nani Daman.
6. The Vendor shall have back up training/technical expertise/spares & tools and after sales service facility.

General Terms & Conditions for EOI

1. The Bidder Company should be a company registered in India as a Private Ltd or Limited company under the Indian Companies Act 1956 a copy to be attached.
2. Interested Bidders should inspect the operation theatre block in General Hospital, Nani Damn, before submission of their EOI to assess requirement. **All the Bidders are bind to have Physical Inspection of project site on any of working hours from 05.08.2013 to 12.08.2013 The Pre-Bid Meeting is also mandatory to attend on 20.08.2013 at 4.00 p.m. no bidder is eligible to bid without conducting the both of the same.**
3. Before submitting a Eol, It is mandatorily applied on the bidder that they will be deemed to have satisfied himself by actual physical inspection of the site and Locality of the works, that all conditions liable to be encountered during the execution of the works are taken into account and that the rates enters in the EOI are adequate and all inclusive to accord with the provisions of

contract for the completion of works to the entire satisfaction of the respective authorized committee.

4. Applicant/Bidders who successfully clear in both EOI & Presentation given by them will only be considered as eligible to step ahead to participate in tendering process, the successful applicant/bidders can get BOQ & Technical Specifications which can be purchased as printed hard copy or the same can be downloaded from our mentioned website <http://www.nrpocure.com>.. Any complaint/objection raised from ineligible applicants/bidders will summarily reject and treated nullified.
5. The applicant company should submit true copy of their last three years balance sheet with audit report duly certified by Chartered Accountant and that also should be not less than Rs. 3 crore and an average of Rs 5Cr. of 3 consecutive years, lack of this will summarily rejects the applicant.
6. At least 100 projects (including Government Projects + Non Government(Private Projects)) of Supply/Installation/Fixing/Commissioning of Modular Operation Theatres should be completed by the applicant company over the past 5 years with no complaints/indict/objections from client/purchaser side.
7. The applicant should have sound technical capacities to undertake the assignment and it would be preferable if the senior officials possess the relevant experience and exposure to execute works. Outsourcing of technical capability shall be deemed cancellation of the bid.
8. The company should be engaged in Modular Operation Theatres since last five years from till date the relevant evidentiary documents should be submitted; the establishment tenure of company should at least be more than 5 years.
9. The applicant company should have ISO & CE certification and having relevant experience of relevant product is eligible.
10. At least 2 projects (Two Projects) worth of INR 1.5 crores should be completed by the applicant company.
11. Any joint Venture/Consortium/Foreign Joint Venture or Consortium/Foreign Investment is not allowed, if found, will disqualify for tender process without any prior notice.
12. The applicant/bidder company should complete/done any relevant government project with similar capacity job profile without any

complaint/indict or legal case from any Government or Non government Hospital/Organization/NGO.

13. The company /organization should worked or working with other state/UT governments, if YES, please attached the adequate evidentiary documents.
14. The applicant company should not impose to pay any penalty/fine in any of the known form whether monetary level or any other type.
15. The applicant company should neither under any inquiry from vigilance nor they should found guilty with any legal case or vigilance inquiry against them, No penalty/fine in any known form i.e. financial etc., will be imposed on the applicant/bidder, it is also very clear that bidder/applicant will treat ineligible if found involved in any Legal case or vigilance inquiry.
16. The applicant company should have exposure towards work execution of turnkey project having HVAC system with having HVAC workforce/consultant.
17. An incomplete and/or ambiguous and/or conditional and/or late response is liable to be ignored/ summarily rejected.
18. The Bidder should have an experience for similar nature work for a period of 5 years and shall submit documentary evidence of satisfactory performance of the Modular OTs" installed/manufactured/fixed by own only.
19. While submitting the sections duly filled in applicant shall enclose latest copies of brochures and technical documentation giving additional information about the applicant. The language for submission of application shall be English only.
20. The enclosed sections should be filled in complete and all questions should be answered. If any particular query is found not relevant to the vendor, it should be indicated as "not applicable.
21. Financial data, project costs, value of works, etc. should be given in Indian Rupees only.
22. Incomplete and inappropriately filled in applications are liable to be rejected.

23. Costs incurred by applicant(s)/bidder in preparation and submission of information/ documents in providing clarifications or attending discussions/meetings, on site visits or due to any other reasons will not be reimbursed by Government/UT Government/Department.
24. Firm will be short-listed based on documents furnished & presentation made for proposed services. The short listed firm by EOI process will be required to participate in the e-tender floated by the department after the presentation. Any objection for selection process will be summarily rejected
25. The UT Administration, reserves all rights to reject any or all the EOI/Tender without assigning any reason.
26. Each page of pre-qualification document shall be duly signed by the applicant or his authorized representative.
27. The following documents must be submitted along with the EOI:
- List of organization available on hand (own) and proposed to be engaged for the work.
 - List of plant and machinery available on hand (own) and proposed to be inducted (Own and hired to be given separately) for the work.
 - List of similar nature of works completed in the last three financial years giving description of work, organization for whom executed, date of award and date actual start, completion date of contract should also be given.
 - List of works on hand indicating description of work of balance work yet to be done and date of award.

Special Terms and Conditions:

1. Delivery & Installation: The ordered items shall be delivered & installed and commissioning within 3(three) Months from the date issue of supply order.

2. Payment Terms & Security deposit: 100% payment shall be made after successful commissioning and taking over by the consignee and after submission of :

1. Certification of acceptance by the Medical Superintendent, Govt. Hospital and counter signed by the Executive Engineer, PWD.

2. 10% Bank Guarantee as security deposit in the form of Bank Guarantee valid for 1 (One) year.

3. Penalty Clause (for supply): The tenderer will be bound to supply the items within the stipulated period as mentioned above, failing which the following penalty will be levied on the tenderer (deducting from the EMD/Security Deposit).

- a. For delayed supply:- A penalty of 0.5% of the total value of order per week will be imposed subject to a maximum of 10% of the total value of the order.
- b. For Non-Supply:- Security Deposit of the firm shall be forfeited.

4. Special Instructions:-

- a. Prices are firm & fixed
- b. Prices accepted are FOR destination in Medical Superintendent, Government Hospital, Daman
- c. You shall furnish original manufacturers test certificate.
- d. Freight & insurance, loading / unloading and incidental expenses, installation & commissioning will be arranged by you at your own cost.

5. COMPREHENSIVE WARRANTY:- The following Guarantee/Warranty Clause shall be applicable and binding on you: Comprehensive Warranty / Guarantee(Initial 5 years:- The seller declares / certify that the goods / stores / articles sold / supplied to the purchaser under this contract shall be New in all respects , are of the best quality, workmanship and shall be strictly in accordance with the specification and particulars contained/ mentioned in the contract. The contractor / seller further guarantees that the said goods / stores would continue to confirm to the given description and quality aforesaid for a period of 60 months from the date of Installation / Commissioning of the said stores/ articles in the premises of the purchaser/ user department. The above guarantee / warrantee is notwithstanding to the fact that the purchaser may have inspected the store / article and / or not within a period of 60 months of thereafter. In case said goods/stores / articles is discovered not to confirm to the description and quality aforesaid or not giving satisfactory performance or have deteriorated at subsequent stage, the purchaser may take such action or issue such directions as deems fit to Tenderer to bring the machine in conformity with prescribed specification / to make it operational and which shall be final and binding on the contractor/ seller.

The purchaser is entitled to call upon the contractor to rectify the goods/Stores/articles or such portion of store as found to be defective by the purchaser within a reasonable period/ or such specified period as may be allowed to the contractor failing which the losses, compensation, damages etc, including the cost of repairing of such store, the contractor is having alternate choice of rectify the same existing goods/stores/articles or he can replace the goods/stores/articles with same or superior quality goods/stores/articles, if the Store/ items/ machine is repaired from open market or such damages as assessed by purchaser, which indenter would suffer due to non-operation of the said article/ instrument, shall be recovered from the tenderer and the firms/ tenderer shall be blacklisted for breach of warranty.

6. Free Annual Maintenance Contract (Next 5 years)

The Tenderer shall further commit to provide unconditional free AMC(labour only) for the next 60 Months (five years) after the completion of Comprehensive Warranty of 60 Months to ensure satisfactory / flawless functioning of the stores to give the desired result. The indenter shall bear only the costs of spares at the prescribed prices, in case required as necessary / essential, to keep the above equipment functional.

7. Uptime guaranty: During the Warranty / Guaranty period, you shall maintain the equipment with 95% uptime. You shall give a written commitment for 95% uptime of the equipment, calculated on annual basis, with penalty equivalent to double the amount of daily cost (on total loss of revenue per day / running cost per day basis) of the unit for each day's delay in proper functioning of the unit beyond 5% down time per annum.

8. Penalty Clause:- The tenderer will be bound to get the equipments repaired within 46 hours of the receiving of the complaint from the indenting hospital failing which a penalty of @ 1% of the cost may be recovered from the Bank Guarantee before releasing the same after 5 years .

9. CORRECTNESS AND COMPLETENESS OF THE STORES:- The stores shall be correct and complete in every respect with all mounting fitting, fixtures , Standard, accessories which are normally supplied even though not specifically detailed to the specification.

10. RECTIFICATION CLAUSE: In the event of stores is given back to the manufacturer should ensure that the defect attended as soon as possible basis and without loss of time so that stores can be re-inspected as earliest. However, it should be noted that the manufacturer will not be entitled to dispose off that stores which is given for rectification / rejecting without prior permission of the inspection.

11. Installation: The equipment shall be installed / demonstrated by you free of cost at consignee premises. You will provide 2 copies of the manual including electric circuit diagram design in free of cost along with the equipment.

12. Intimation of dispatch: The documents should be in the name of consignee only. The information regarding shipment should be sent to the institution well in advance. Delay in submission of relevant information/ incorrect document, and any such information due to which the clearance of stores is delayed, the demurrage charges shall be to your accounts.

13. LIABILITY: Supplier's responsibility shall be up to consignee's warehouse/ premises. However, you will be responsible for any damages/ losses due to defective packing etc.

14. TRAINING: You shall provide onsite training to Medical & Technical Staff.

15. Insurance : You shall take cover from warehouse basis and shall keep it valid until store reach hospital at Daman leaving sufficient time for necessary installation and commissioning.

16. Service after expiry of warranty of 5 Years and AMC of 5 Years : After the expiry of this period, you will enter into annual maintenance contract on mutually agreed terms & conditions for further maintenance of the whole equipment as per your tender.

17. EOI must be accompanied with a SHE(Safety, Health & Environment) Policy, project organization (Flow chart), project organization (Duties and Responsibilities),

project Control and Administration Methodology of working, Self Test and inspection Plan, non conformity and corrective Actions, Safety , monitoring mechanism.
