

TERMS AND CONDITION:

1. The interested bidder must submit a copy of their PAN Card, residential proof i.e. Ration Card, Voter ID card, etc. without it, will not be entertained.
2. The interested bidder shall have to deposit an amount of Rs. 1000/- to become eligible to participate in the auction.
3. The bid will start from the upset price as shown in the auction notice.
4. The eligible participate will offer bid in the round up to Rs. 100/- for above upset price.
5. An offer will be considered as highest and final only if the amount offered by the bidder is announced consequently three times uninterrupted.
6. The successful highest bidder will have to deposit on the spot an amount equal to 25% on the total of his offer/bid.
7. The successful highest bidder will have to lift all the listed furniture etc upon the payment of full amount as per his bid within 07 days from the date of issue of letter accepting his/their highest bid.
8. In case of failure of the highest bidder to deposit the amount of 25% on the total amount of his/her bid the deposit made for security eligibility to participate in the auction will stand confiscated to the Government.
9. In case of the failure of the higher bidder(s) to lift the entire quantity of the relevant materials i.e. listed furniture etc within the given period the amount of 25% of the total amount as per his/their bid will be confiscated.
10. Further the amount to be deposited/paid as per condition No. 6 & 7 above will be adjusted according to the actual number of relevant materials and the amount of Rs. 1000/- as deposited under condition No. 4 above will be adjusted against demand under condition No. 9.
11. Power to accept or reject the highest bid without assigning any reasons is reserved by the H.O. of Office of Public Prosecutor, Daman.
12. The decision to accept / reject any/ highest bid (s) will be communicated within 60 days from the date of auction.
13. The above conditions are pronounced loudly in the presence of us and we shall sign here below in token thereof.
14. Dispute, if any, shall be subject to Daman Jurisdiction only.
