- 3 The interested parties should have the above mentioned items ready in their stock for supply. The delivery of F O R is to be made at Govt. Horticulture Farm, Moti Daman, within 15 days, from the date of issue of date of supply Order.
- 4 The items to be supplied should have been produced/ manufactured, packed, labelled and being sold in conformity with the provisions of relevant Acts/ Rules in force.
- 5 To examine the credentials, the random sampling of the items will be done in accordance with established norms. The items found defective or damaged or otherwise not conforming to the given specifications will be rejected and the supplier will be liable to replace the same within specified period of time in within 15 days.
- 6 The quantity to be supplied will be subject to replacement without prior notice.
- 7 The EMD should be furnished in the form of Demand Draft drawn in the favour of **Chief Executive Officer, District Panchayat, Daman & Diu, Daman** and the same should be enclosed with sealed tender document. Tender received without enclosing specified EMD shall be summarily rejected.
- 8 No Advance payment will be made paid until materials is received and will be paid on passing of bill.
- 9 Interested parties should be registered with VAT Deptt. of the State / UT in which its HO/Sale office is located and should submit the copy of VAT Registration Certificate along with copy of PAN.


