- 1. The rate(s) quoted should be strictly for free delivery F.O.R. at Govt. I.T.I., Daman and will be valid and operative for supply orders issued on or before 31/3/2014 from the date of invitation of tenders and inclusive of all Taxes, installation & commissioning charges.
- 2. All Taxes/ Duties/ Royalties charges payable on sales/transport etc. within and / or outside the UT / State shall be payable by the supplier.
- No extra charge for packing, forwarding and insurance etc. will be paid on the rates quoted.
- 4. The rates should be quoted only for the items specified in the list of requirement and should be for the items of given special mark / manufacture.
- Rates quoted for items other than required specification/mark/manufacturer may not be considered.

- 30. The supplies of Plastic Injection Moulding Machine with Microprocessor Control of inferior quality standard or of different specifications, content, brand, manufacturer etc. other than that ordered specified and/or incomplete or broken articles will not be accepted. The supplier has to replace the same at his own cost and risk.
