TERMS & CONDITIONS :-

1. The auction of Ambassador Car bearing Registration No. DD 03 – C – 0100 and Mahindra & Mahindra Jeep bearing Registration No. DD 03 – 0021 shall be carried out under the supervision of the committee consisting of the Executive Engineer, PWD, Daman, the Assistant Engineer, PWD, SD-IV, Daman & Divisional Accountant, P.W.D., WD-I, Daman on 18/01/2014 at 11.00 AM.
2. The interested bidder shall have to deposit a token amount of Rs. 500/- and Rs. 600/- for respective vehicle at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
3. The bidder should offer bid for a minimum of Rs. 500/- (Rupees five hundred only) above the upset price of each vehicle.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
5. The upset price of two vehicle are Rs. 25,000/- & Rs. 30,000/- for Ambassador Car and Mahindra & Mahindra Jeep.
6. The successful bidder shall have to lift the auctioned vehicles within three days from the date of finalization of the auction after which this office shall not be responsible for their safe custody.
