TERMS & CONDITIONS :-

1. The auction of **Ambassador Car** bearing Registration No. **DD 03 – C – 0006** shall be carried out under the supervision of the committee consisting of the Executive Engineer, PWD, Daman, the Assistant Engineer, PWD, SD-IV, Daman & Divisional Accountant, P.W.D., WD-I, Daman on 28/02/2014 at 11.00 AM.
2. The interested bidder shall have to deposit a token amount of ₹.500/- at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
3. The bidder should offer bid for a minimum of ₹.500/- (Rupees five hundred only) above the upset price of each vehicle.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
5. The upset price of vehicle is ₹.20,000/- for **Ambassador Car**.
6. The successful bidder shall have to lift the auctioned vehicles within three days from the date of finalization of the auction after which this office shall not be responsible for their safe custody.
7. The interested parties should inspect the vehicle and satisfy themselves about their conditions etc. during office hours Monday to Friday up to 17.00 hrs.
8. The bid shall be considered as final only after approval of the Committee and its decision as regards to any dispute arising in the course of the auction shall be final and binding on all the persons participating in the auction.
9. Right to accept or reject any bid or all the bids without assigning any reason is reserved by the Committee.
