Term & condition :-

- 1 The interested parties should quote their offer/ rates on letter-head under their signature & seal.
- 2 The rates should be inclusive of all taxes & valid up to 180 days.
- 3 The Rates for insecticides/ pesticides/ fungicides should be inclusive all taxes & quoted for FOR at Govt. Horticulture Farm, Moti Daman.
- 4 The interested parties should have the above mentioned items ready in their stock for supply. The delivery of F O R is to be made at Govt. Horticulture Farm, Moti Daman. within 15 days, from the date of issue of date of supply Order.
- 5 The insecticides/ pesticides/ fungicides to be supplied should have been manufactured, packed, labelled and being sold in conformity with the provisions of Acts/ Rules in force. The secondary package should display the details of product, including technical details, ISI Mark certificate, price, expiry date. The expiry date of the products to be supplied should not be earlier than one year from the date of supply.
- 6 To examine the credentials, the random sampling of the items will be done in accordance with established norms. The insecticides/ pesticides/ fungicides which found to be defective or damaged condition and not conforming to the given specifications will be rejected and the supplier will be liable to replace the same within specified period of time in within 15 days.
- 7 The quantity to be supplied will be subject to replacement without prior notice.
- 8 The EMD, shall be furnished in the form of valid FDR or DD drawn in the name of **Chief Executive Officer, District Panchayat, Daman** and the same should be Enclosed with sealed tender. Tender received without enclosing specified EMD, if demanded, shall be rejected. EMD of the Successful Tenderer will be retained till 180 days. EMDs of the unsuccessful Tenderers will be released to them within 15 days from the date of opening of Tenders.
- 9 Interested parties should be registered with VAT Deptt. of the State / UT in which its HO/Sale office is located and should submit the copy of VAT Registration Certificate alongwith copy of licence.
- 10 The payment will be made through direct bank accounts only after successful completion of supply to the satisfaction Chief Executive Officer, District Panchayat, Daman.
- 11 The tender forms are available up to 20/11/2015 and may be obtained after payment of Rs.500/- Cash (Rs. Five Hundred only Non refundable) during working hours on any working day from Agriculture Section, District Panchayat, Dholar, Moti Daman, Daman.
