**NOTICE INVITING CLOSED BIDS FOR HARVESTING/ SALE OF CHIKOO FRUITS**

Closed bids are hereby invited from the interested parties up to 12:00 Hrs on 24/11/2015 for harvesting/ sale of chikoo fruits from trees in the Govt. Horticulture Farm, Moti Daman, during the period w.e.f. 01/12/2015 to 31/10/2016, subject to terms & conditions given below :-

**TERMS AND CONDITIONS :-**

1. The upset price for the bid is **Rs.4500/-**.The intended bidders are required to bid above the upset price.
2. The bid shall be given on plain paper with signature and submitted in the name of Chief Executive Officer, District Panchayat, Daman in a sealed cover super scribed as "Bid for Sale of Chikoo Fruits".
3. The bids will be opened on 24/11/2015 at 04:00 pm in presence of the Members of the Committee constituted for the purpose and the bidders or their representatives, if any.
4. The highest bidder shall be the "successful bidder". The successful bidder shall have to deposit bid amount with Chief Executive Officer, District Panchayat, Daman on or before the date of taking over of the possession of the orchard/ trees.
5. The Chikoo Orchard is open for the inspection by the intended person(s) between 10:00 Hrs to 17:00 Hrs on any working day, however, with prior permission of the I/c of Govt. Horticulture Farm, Moti Daman, The I/c of Govt. Horticulture Farm, Moti Daman, has authority to deny such permission for the reasons not to be explained to the interested person (s).
6. After taking over the possession of the trees in the orchard, the successful bidder shall make the proper inventory showing the details, including the health status, of trees and obtain countersignature of the I/c of Govt. Horticulture Farm, Moti Daman.
7. No any kind of damage shall be caused to the trees and other property of the Farm. In case of any such damage, the successful bidder has to compensate the same as per instructions of the I/c. of Govt. Horticulture Farm, Moti Daman,. Failing which, the bidder will not be allowed to continue the harvesting of Chikoo Fruits. The Government shall not be responsible for the damages occurred to the bidder on account of such discontinuation of harvesting The harvesting/ grading/ transportation/ sale of fruits is allowed on all working days during working hours till 31/10/2016 at the responsibility & cost of successful bidder.
8. Assigning of any tree or trees in the orchard to other parties, by any mean, by the successful bidder is not allowed under any circumstances.
9. All maintenance operations of the orchard will be carried out by the department at its own costs.
10. The right to accept or to reject any or all bids, without assigning any reason thereof, is reserved with the Chief Executive Officer, District Panchayat, Daman.
