TERMS AND CONDITIONS

- The service providers/person shall not claim any benefit / compensation / absorption / regularization of service with office under the provision of Industrial Disputes Act, 1947 or Contract Labour (Regulation & Abolition) Act, 1970. Undertaking from the person to this effect will be required to be submitted by the service provider to this office.
- 2. The period of outsource Shall initially period of one year from the date of commencement and further renewal For another 2 year at same rate will be based on subject to satisfactory work performance and discretion of the Head of Office.
- 3. The service providers/person has to cover whole Daman District including rural (Panchayat), Urban (Municipal Wards), industrial, chawls, gutters, Open plots, new building constructions sites and other potential site for mosquito breeding as decided by the department.
- 4. Two technical officers, eight Technical supervisors and 50 Nos of person will be responsible to carry out Vector Borne Diseases (VBD) Control Activities in whole Daman District.
- 5. The Field VBD control Activities must be designed in such a way that whole of the Daman District will be surveyed completely every week.
- 6. The person deployed shall not claim any Master-Servant relationship against this office. The service provider for providing services as mentioned here in shall be the employer of the Outsource man power.
- 7. The persons supplied by the agency should not have any adverse Police records / criminal cases against them. The agency should make adequate enquiries and certify about the character and antecedents of the persons whom they are recommending. The Health Department may dismiss or remove any person or persons, employed by the service provider, who may be incompetent or his/her/their misconduct and service provider shall forthwith comply with such requirement.
