- The successful bidder shall have to produce a copy invoice for purchase of uniform cloths (particular brand) of the company or authorized distributor/dealer along with the supply of uniform.
- The size and measurement of uniform kit articles items and sample for the same can be had from Fire & Emergency Services, Somnath, Nani Daman.
- The tenderer will have to be produce sample of the items quoted along with tender. Tenders received without sample will be summarily rejected.
- The rate tendered should be strictly for free delivery at Fire & Emergency Services, Somnath, Nani Daman.
