Contractors who fulfill the Minimum Pre-Qualification requirement shall be eligible to apply:-

- 1) Registered with CPWD and those of appropriate list of Department of Telecommunications, MES, Railways, State Development Authorities, Municipal Corporation, State PWD under appropriate class.
- 2) The Tenderers should have an experience of having completed such nature of works during the last 5 years ending March, 2015.

Three similar completed works costing not less than the amount equal to **40%** of Estimated cost put to tender **OR** Two similar completed works, costing not less than the amount equal to **60%** of Estimated cost put to tender **OR** One similar completed work of aggregate cost not less than amount equal to **80%** of estimated cost.

Similar work means the Furnishing work.

One work of any nature of minimum 40% of estimated cost should have been executed in Central Government / Central Autonomous Bodies / Central Public Sector Undertakings). Similar work means the Furnishing work.

- 3) <u>Turnover</u>: Average annual financial turnover on construction work should be at least Estimated Cost during the last 3 financial years.
- 4) <u>Solvency Certificate</u>: The contractor should provide a valid solvency certificate of 40% amount of Estimate cost put to tender.

OIDC reserves the right to reject any or all tenders without assigning any reason and the selection shall be at the absolute discretion of the Corporation and Corporation's decision in this respect shall be final and binding.
