5. The payment will be made after completion of whole supply and at the satisfaction of this Department.
6. Income Tax will be deducted as per the I.T. Rules. Labour cess will also be deducted as per rules.
7. The sealed tender should reach this office up to 02:00 P.M. on 26/09/2016 in sealed envelope super scribed as "Tenders for the work of "Supply of Tree Guards" and it will be opened on the same day if possible in presence of bidders or their representatives, if present.

9. The quality of material if not found good or otherwise and not as per given specification shall be rejected. The firm should replace the same; failing which, the payment shall not be done.
