
TERMS AND CONDITIONS FOR INSTALLATION OF DEDICATED BANDWIDTH OF 2MBPS INTERNET LEASE LINE FOR THE POLICE DEPARTMENT, DAMAN FOR THE YEAR 2016-17.

1. The rate(s) quoted shall imply free delivery and installation of the equipment to the Police Department including Transportation, loading/unloading etc. The rate will be valid and operative for one year from the date of issue of work order.
2. The rate should be quoted inclusive of all taxes and F.O.R. at our Daman Police Head Quarters only.
3. The firm/Agencies/dealer/manufacture must have CST/VAT registrations with concern Government department and should be attached with *tender* documents.
4. The bid shall consist of all documents / papers mentioned in the *tender* document. The bid(s) so received from the bidder will be opened by the committee.
5. The **Earnest Money Deposit** for an amount of **Rs.2,500/-** (Rupees Two Thousand Five Hundred Only) in form of **Fixed Deposit Receipt / Demand Draft** only from any **Nationalized / Scheduled Bank** drawn in favour of the “DIGP DD, Daman”. ***Tender without EMD will not be considered and tender will be summarily rejected.*** The validity of the FDR shall be for a minimum of six months.
6. The rates should be quoted only for the items specified in the schedule of requirements and should be for the items or given specifications conform to the standard (s) requirements of the given specification/mark/manufactures.
7. Rates quoted for items other than the required specification/mark/manufacture may not be considered. However indigenous manufacture (s) may quote their own makes provided.
8. Where specifications/mark/ manufacture is not specified by this office the rates should be quoted only for the 1st Class and standard quality.
9. The successful bidder has to give services and repair of Internet connectivity strictly as per specification shown in Schedule and within 12 hours time limit. If the material supplied not found as per the specification, the entire supply order liable for cancellation and E.M.D./Security Deposit paid will be forfeited to Government and said agency shall be blacklisted.

13. In case of failure to provide services, as per conditions and within stipulated time, the same will be procured if required, from the bidder who offered next lowest or from any other sources as may be decided by the *tender* Inviting Authority and the loss to Government on account of such purchase (s) shall be recovered from the original supplier's from E.M.D./ Security Deposit or bills payable. **The supplier shall have no right to dispute with such procedure.**
14. If at any time, after the order placed to the agency for provide services of Internet connectivity for any reason whatsoever not required in whole or part of the quantity thereof as specified in the order, the *tender* Inviting Authority shall give notice in writing to supplier for such curtailment and in such case, the supplier shall have no claim for compensation by reason of any alteration which shall involve any curtailment or the supply originally contemplated.
15. The E.M.D. / Security Deposit paid by the bidder(s) earlier against any other quotation(s) or supply is/are not adjustable with E.M.D./Security Deposit required for this work/quotation.
16. If the supplier, whose quotation is accepted, fails to execute the work order within the stipulated time, the E.M.D./Security Deposit of such bidder will stand forfeited to the Government and the contract for the supply shall stand terminated with no further liabilities on either part to the contract.
17. If any dispute arises, the case shall be decided within the jurisdiction of Daman District.
18. Right to accept or reject without assigning any reason, thereof, any or all *tenders* in part or in whole is reserved with the *tender* Inviting Authority and his decision(s) or all matters relating to acceptance or rejection of the quotations as a whole or in part will be final and binding to all.
