Evaluation Methodology

Total Bid Evaluation: - <u>The Technical bid shall have a weighted at 70 Marks</u> in the <u>overall evaluation of the bid and the Commercial bid shall have a weighted at 30 Marks</u> in the overall evaluation.

Tender awarding committee or Purchase committee of Police department will evaluate and compare the bids determined to be substantially responsive. The intent is to select the Tender that is most advantageous to Police department and each Tender will be evaluated using the criteria and points outlined below.

The essential qualifying evaluation criteria for the technical bid are as follows:

Contractor/ party/ Suppliers/firm /Bidder/consortiums found qualify in technical bid to be eligible for their financial bid to be opened.

Each of the financial bids submitted shall be evaluated based on the following formula.

Formula for Normalization of Financial bid for each bidder $Fn = (Fmin / Fb) \times 30$ Where Fb is the total Bidder/consortium's financial bid value and Fmin is the Lowest bid (L1) value out of all bidders and 30 is the total marks for the Financial Bid.

The Lowest bid (L1) will be the highest of score obtained in (Tn+Fn) i.e (Technical Bid + Financial Bid)

Terms & Conditions

- 1. This shall include CAMC cost inclusive of all the taxes.
- 2. The Bidder must submit evidence of at least one similar nature of work done by him within a year.
- 3. Bidders are advised to study all technical and commercial aspects, instructions, terms and specifications carefully in the Bid document. Failure to furnish all information required in the Bid document in every respect will be at the bidder's risk and may result in the rejection of the Bid.
- 4. Bidders are advised to visit the place/ premises to view the location and type of CCTV Cameras installed before submitting the bid documents.
- 5. The rate shall be quoted for all 23 cameras installed at 14 locations and shall be inclusive of all taxes / VAT's and other charges such as delivery, installation and commissioning etc.
- 6. Bidder should attach copy of experience if any, along with necessary endorsement.
- 7. The cover thus prepared should also indicate clearly the name, address and mobile number of the bidder to enable the bid to be returned unopened in case it is declared "late".
- 8. Bid document should be signed by authorized signatory of firm or by proprietor himself/herself. Certificate of authorization should also be attached. Corrections, erasures, over-writings in the bid documents shall be valid only if initiated by the person or persons signing the bid.
- 9. All payments are subject to statutory deductions as and when applicable.
- 10. CONTRACT PERIOD: The Contract is valid for three years. The Contract period may be extended further to successful bidder if performance found satisfactory.
- 11.PAYMENT: Payment will be made on quarterly basis on submission of bills in triplicate by the contractor. The rates remain same during the entire period of the contract and no escalation shall be payable under whatsoever reason. No sub-contractor will be engaged without written permission of the Tender Inviting Authority.
- 12. The Tender Inviting Authority reserves the right to terminate the contract at any time without notice if the work is found un-satisfactory and also get the work done through any other agency at the risk and cost of the Contractor.
- 13. In case of any technical snag it should be attended within 12 hours. However, all efforts should be made to attend the snag forthwith.
- 14. <u>CONTRACTORS RESPONSIBILITY</u>: The firm should ensure that no delay should occur in responding, attending to any complaint, problem such as repairing, rectification of cameras. In the event of any consistent delay or failure in attending the problem of cameras for two or more occasions in a span of 7 days, the Tender Inviting Authority shall reserve the rights to cancel the contract forthwith and also to make alternative arrangement at the full risk and cost of the firm. Such cost would be recovered from the periodical service bills in addition to imposing a penalty for each

such incident of delayed reporting. Penalty will be decided by Tender Inviting Authority or Superintendent of Police, (HQ) or DIGP Daman & Diu and DNH.

15. <u>PERFORMANCE SECURITY</u>: The successful bidder shall give performance security in the form of Account Payee Demand Draft / Fixed Deposit Receipt any Nationalized Bank amounting to 10% of the total Contractual value in favour of "DIGP DD & DNH, Daman". Performance Security should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the supplier including warranty obligations. The Security Deposit will be refunded only after the expiry of the contract.

16. Scope of Work of Comprehensive Annual Maintenance of CCTV Systems

A. All the Cameras installed at Daman District like Camera of Samsung Make, and as mentioned in the Technical Specification of the tender document with Power supplies and Network Cabling etc., related to CCTV Systems shall be maintained by the contractor with Preventive Maintenance i.e., once in every month during the contract period to ensure proper functioning of the CCTV Surveillance System.

B. A monthly maintenance chart should be maintained and be signed from Dy. S. P. (HQ) Daman with a counter signature of I/C CCTV Camera System.

C. The Contract shall cover Spot Breakdown Maintenance, Preventive Maintenance and Servicing, Repairing of cameras, Transportation of cameras. The efficiency of cameras and other equipments shall be ensured.

D. In case of defect due to force majeure conditions needing replacement of CCTV cables, power cables and other spares shall be arranged by the contractor.

E. Every item used in functioning the CCTV camera system including tower repairing painting, cabling, spare, has been covered under the CAMC contract and contractor will be responsible install new or repair existing spare, equipment.

16. In case of any disagreement in scope of work after the assignment of Comprehensive Annual Maintenance Contract (CAMC), then the scope of work as mentioned above in terms & condition at Sr. No. 15 shall prevail.

17. Documents to be submitted with Tender : -

The Tender properly bound and serial numbered shall essentially contain the following:
