The Public Works Committee, District Panchayat., Daman here by invites online Auction on behalf of the president of India from the interested parties for **"Deepening of pond of 1) Pariyari Varliwad Talav,2) Ramkund Talav in Daman District "**. including disposal of serviceable and unserviceable material with all lead and lift including loading, taking away the materials from the site and clearing the site in all respect as directed by the Engineer – in – charge, last date for online submission of the bid is **17/05 /2018 upto 3.00 p.m** & Online opening of Price Bid is **17/05 /2018 upto 4.00 p.m. ( if possible)**


- (1) The upset price Rs. **62,58,727.00** is fixed for "Deepening of pond of 1) Pariyari Varliwad Talav,2) Ramkund Talav in Daman District" including disposal of all Serviceable & unserviceable materials from the site. The approximate quantity of murrum /soil shall be total **49739.54 Cu.mt.**(as per pond wise detail of quantity given below)
  - a) Pariyari Varliwad Talav - 31771.79 cmt
  - b) Ramkund Talav - 17967.75 cmt
- (1) The highest bidder has to deposit minimum **Rs.62,58,727.00** (including Royalty) to the department with condition that the Contractor / Agency should excavate the earth/Murrum along with transportation for the said ponds as per the quantity given in Tender/auction condition.
- (2) The Tender/bids will be opened on the same day if possible in presence of available prospective Contractor/bidders.
- (3) The highest bidder will have to deposit the amount offered by him by cheque as per the Mode of Payment as mentioned in STC from the issue of letter accepting his bid.
- (4) The intending Contractors/bidders should submit their document in hard copy including E.M.D , Tender fee and other documents to the office of the **Executive Engineer, P.W.D., District Panchayat Daman** on or before **17/05 /2018 upto 3.00 p.m.**
- (5) The tender fee Rs . **1000.00** in Demand Draft (Non refundable)
- (6) The Contractors/bidders should furnish a E.M.D. of Rs.125180.00 in the form of F.D.R. valid for period of six month (180 days) or more before the last date of receipt of tenderer/bid.
- (7) The tender/bid received without tender fee in DD & E.M.D. in the form of F.D.R. shall be rejected.

(8) Time limit allowed for the work is (45 Days)

(9) Right to issue and to accept or reject any or all the bids without assigning any reason there of is reserved by the undersigned.
