

**The condition for apply are as under:**

- 1 The interested parties should quote their offer/ rates on letter-head under their signature & seal along with Tender form.
- 2 The rates should be inclusive of all taxes & valid up to 180 days from the date of opening of the Tender .
- 3 The interested parties should have the above mentioned items ready in their stock for supply. The delivery of FOR is to be made at Veterinary Section, District Panchayat, Moti Daman. within 15 days, from the date of issue of supply Order.
- 4 The items to be supplied should have been produced/ manufactured, packed, labelled and being sold in conformity with the provisions of relevant Acts/ Rules in force.
- 5 To examine the credentials, the random sampling of the items will be done in accordance with the established norms. The items found defective or damaged or otherwise not conforming to the given specifications will be rejected and the supplier will be liable to replace the same within specified period of time in 15 days.
- 6 The quantity to be supplied will be subject to replacement without prior notice.
- 7 The EMD should be furnished in the form of FDR /DD drawn in the favour of **Chief Executive Officer, District Panchayat, Daman** and the same should be enclosed with sealed tender document. Tender received without specified EMD shall be summarily rejected. EMD of the Successful Tender will be retained till thirty days from 31<sup>st</sup> March. EMDs of the unsuccessful Tenderers will be released to them within 30 days from the date of opening of Tenders.
- 8 The interested parties should submit the copies of the Income Tax Returns filed by them for the last two Assessment years, Medicine/Drug Licence along with copy of PAN & GST Registration.
- 9 The payment will be made through RTGS/Direct bank account only after successful completion of supply to the satisfaction of the Chief Executive Officer, District Panchayat, Daman.
- 10 The tender forms along with terms & conditions can be downloaded from the Website [www.daman.nic.in](http://www.daman.nic.in) & payment of Tender Fee RS.500/- (Five Hundred only) in the form of DD in name of **Chief Executive Officer, District Panchayat, Daman**, from any Nationalised bank ( Non Refundable) to be submitted along with tender document.
