The society proposes to decorate all the barracks, open spaces, of Government house, Secretariat Building, Light house, Collector Building, Fort wall Nani Daman and entire walls of Moti Daman along with all the inside patches, (Both side, Jetty Side and Rajiv Gandhi Sethu, Moti Daman) on the occasion of Daman Festival 2019 for 17,18 and 19 December 2019.

The price bid should be submitted on www.ddtenders.gov.in only in electronic format only.
- 5) Tender fees of Rs. 5000/- will be accepted in the form of Demand Draft in favour of the Member Secretary-SPOTAC, Daman From Nationalized / Scheduled bank payable at Daman. E.M.D. of Rs. 1,50,000/-will be accepted in the form of FDR / Bank guarantee in favour of the Member Secretary-SPOTAC, Daman From Nationalized / Scheduled bank payable at Daman.

- 6) The Tender offer without payment of Tender Fees and E.M.D. or with incomplete details as mentioned in this tender document will not be considered.
- 7) The Tender will have to submit the offer online only on <u>www.ddtenders.gov.in</u>

  - 9) All the Xerox copies of documents/certificates required to be submitted should be self attested.
  - 10) Right to split up the Tender or to reject any or all the tenders without assigning any reason there of is reserved by the undersigned.
  - 11) A Tender not bearing signature with rubber stamp of the firm of the tenderer on all page /documents accompanying, will berejected.
  - 12) The submission of the Tender by Tenderer implies that has read these instructions and conditions of the contract etc., and he had made himself aware of the scope & specification of the work to be done.
  - 13) The rates shall be quoted in the rate schedule. The rates and amount shall be written both in words and figures. The Tender documents shall be written legibly and shall be free from eraser. Overwriting or conversion of figures correction and where unavoidable shall be made by Crossing out initiating, date and rewriting.
  - 14) The rates quoted should be firm and price variation will not be applicable and the rate should be quoted including of alltaxes.
  - 15) Tender offer should be valid for 120 days from the date of opening of the Tender.
  - 16) Period of Contract : For a period of Three (03) days
  - 17) Tenderer will have to carry out the above work as per the scope of work & as per directives of SPOTAC, Daman

## 18) Qualifying Requirement/Eligibility Criteria

- 1. Experience in Similar works (Lighting decoration, Stage Lighting and Sound) in Government Utilities/Board/Government undertaking/Distribution Company.
  - a) One Work of amount not less than 16 lacs each Or
  - b) Two work of amount not less than 10 lacs each Or
  - c) Three work of amount not less than 8 lacs each

2. Bidder should have a average annual turnover of Rs. 20,00,000/- in the last three years duly certified by C.A.

3. Bidder should have minimum class of contractor registration from any state govt. department like R&B, Local body, etc.

- 4. Bidder should have electrical contractor license issued from govt. authority.
- 5. Bidder should have GST Registration.
- 6. Bidder should have P.F. Registration.
- 19) The technical bids shall be opened on 25<sup>th</sup> November 2019 at 12:30 hrs. The bidder who has submitted all above qualifying requirement will call for presentation and the Date time and venue will be intimated. The financial bids shall be opened after presentation and the Date time and venue will be intimated. The scoring criteria to be used for evaluation shall be as follows:

### 20) Selection procedure:

A selection committee will evaluate the technical as well as financial bids for event separately on last date of submission and the below evaluation process shall be carried out. The technical bids of all tenders will be opened first.

The technical evaluation will carry a weightage of 50 marks. The financial bid will carry weightage of 50 marks.

The lowest financial offer will b the benchmark for evaluation and will get 50 marks and the next higher offer will be evaluated in the form of lowest rate X50/offered rate.

The agency which scores the highest aggregate marks on the basis of cumulative marks obtained in technical and financial bids (after adding the scores from the technical and financial evaluation) will be awarded the contract for execution

- 21) The Tenderer will have to pay security deposit within 7 days from the date of receipt of the work order, amounting 10% of the value of the contract in the form of FDR/Bank Guarantee of any nationalized/Scheduled bank in the favor of the Member Secretary SPOTAC Daman valid for one year The security deposit will be refunded only after satisfactory completion of the work.
- 22) Failure to furnish the security Deposit within the specified period shall entail to forfeiture of the EMD and cancellation of the contract.

- 23) The tenderer will have to arrange for the transport of material, Man power, machinery, equipments and T & Ps etc at his own cost at the site.
- 24) SUPERVISION OF THE WORKS: The Works shall be under the overall supervision of the Concerned Executive Engg. (O & M), & concerned Assistant/Junior Engineer. The Tenderer shall obtain a certificate from the concerned Assistant/Junior Engineer for having executed the works satisfactorily.
- 25) Payment: The payment shall be released after successfully execution of the said work and after submission of the work completion certificate from the Department of Electricity.
- 26) The Income Tax & GST at the rate applicable will be recovered from your bills as per Government rule.
- 27) All royalties and all local and other taxes / duties etc. shall be paid by the Tenderer at his cost.
- 28) If Tenderer fail to execute the work, it will be treated as breach of contract & contract will be terminated and order will be cancelled by forfeiting the EMD / security deposit.
- 29) CONTRACTOR'S EMPLOYEES: Tenderer will have to employ and provide on site Only such employees who are skilled and experienced for execution and supervision of works. Tenderer will have to provide housing accommodations to his employees. Tenderer will also responsible for any injury / accident to his employees. Payments of compensations for any accident etc. as may required to be paid eventually shall be borne by the Tenderer. Tenderer should ensure that his staff uses the requisite safety equipment. The employees should be duly insured against any such eventually.
- 30) DAMAGE TO PERSONS AND PROPERTY: Tenderer will indemnify the Department against any losses and claims regarding any injuries or damage to any person, material or physically damage any property whatsoever which may arise out of or in consequence of the execution of work. During execution of work any damage / loss to Transmission Company's property occurs will be recovered from contractor bill.
- 31) PRECAUTIONS: Tenderer will have to take all safety precautions at his own; & hand over the site to without any damage .
- 32) Penalty : On expired of period of contract the penalty will be levied at the rate of ½ % per week, subject to the maximum of 5 % of the total value of the contract, once the maximum is reached the society may consider termination of the contract.

- 33) TERMINATION FOR CONTRACT: The undersigned reserves the right to cancel the contract, after giving due notice to you, in the event of the breach of contract in any respect or undue delay in execution of works /starting of the works.
- 34) In case of any dispute arising out of your contract, it will be in the jurisdiction of court in Daman only.
- 35) ADDITIONAL WORK: If, in the opinion of the Authority, it is necessary to carry out any work outside of the scope of this tender for the purposes of the Assignment in addition to the Services, the Bidder, shall carry out such additional work and with the prior authorization of the Authority. Fees for such additional work shall be decided by mutual agreement at rate similar to that finalized for other similar project.
