#### 2. TECHNICAL SPECIFICATION

All the digital educational contents for syllabus from 1st to 12<sup>th</sup> should follow the text book-based curriculum of the Gujarat State Board/Maharashtra State Board/NCERT/CBSE. Educational contents provided should also include Languages Gujarati, Hindi, English and Marathi.
