- 3. The tender inviting authority reserves the right to accept or reject any or all the tender to be received without assigning any reasons thereof.

- 2. All HOD, Daman for wide publicity.
- 3. The Director (IT), Secretariat, Daman for publishing on the official website.

#### **TERMS & CONDITIONS:**

- 1) The rate should be quoted in the prescribed form given by the department; the rate should be inclusive of all taxes and charges. No extra charges for supplying, weighing, insurance etc. will be paid on the quoted rates.
- 2) The rates will be valid up to two years from the date of tenderization.
- 3) The tenders will be open in presence of Tender Acceptance Committee and Tenderer or their representatives.
- 4) Earnest Money Deposit for an amount of Rs. 108,000/- and Tender Fee of Rs. 2,000/- in the form of DD from any Nationalized Scheduled Bank drawn in favour of the Tender Inviting Authority should be attached with the Bid. Tender received without EMD or Tender Fee will not be considered and summarily be rejected.
- 5) The successful bidder will have to pay Security Deposit of an amount of equal 10% of the total value of the article within ten days from the demand, failing which, order of supply will automatically be cancelled without any intimation. The amount of EMD paid by the successful bidder will be adjusted against the amount of Security Deposit to be paid by the successful bidder.
- 6) The EMD / SD paid will be refunded only after satisfactorily completion of the supplied order for and on submission of all bills of the supplies as to be admitted for payment.
- 7) The amount of EMD paid by the tenderers, whose tender is not accepted, will be refunded to them.
- 8) The Bidder must upload the scanned copies of all the mandatory / optional documents duly signed and stamped by the bidder compulsorily online while submission of bid. The mandatory documents are as under:
  - a. Copy of Tender Fee.
  - b. Copy of Earnest Money Demand (EMD).
  - c. Copy of Certificate of GST Registration.
  - d. Copy of PAN Card.
  - e. Food License.
  - f. Copy of Terms and Conditions duly signed and stamped by the bidder.
- 9) No advance payment will be made in any circumstances.
- 10) All bills should be in triplicate and shall invariably mention the under and date of the order. Payment will be given in every next month after the completion of 20 days.
- 11) No separate agreement will be required to be signed by successful tenderer for supply of food.
- 12) For legal purpose, the schedule of rate and terms and conditions shall be dully signed with stamp by the tenderer.
- 13) Right to accept the quotation in whole or in part or to reject any or all bidder without assigning any reasons is reserved by the department.
- 14) Any dispute will be subject to Daman & Diu jurisdiction only.
- 15) The successful bidder has to supply cooked food, Tea and Breakfast to the Jail Inmates of the Daman Sub-Jail as shown in Schedule and as per approved / accepted within prescribed time limit. If the food supplied not found as per the approved

scheduled, the entire supply order liable for cancellation and EMD / SD paid will be forfeited to the Government.

- 16) In case, there is any complaint or cooked food supplied is not as per ratio / quantity or standard or quality is not observed than cooked food will be examined through Govt. Officer or Doctor. If the complaint is found correct, the contract will be cancelled and forfeited to the Government. In such case, new tender will be invited for fixing fresh supplier and in doing this, extra / excess expenditure incurred by the Govt. will be recovered from you and you will be held responsible for such loss to the Govt.
- 17) The supplier has to supply the total quantity of food as per the supply order at one instance in stipulated time period. Part supply / part quantity will not be accepted.
- 18) In case of failure to replace the non-accepted / rejected food, as mentioned in the condition no. 15 & 16 above, the loss undergone by the Govt. will be recovered from the supplier's EMD / SD or payment due any bill to the extent required.
- 19) If the tenderer, whose tender is accepted, fails to execute the supply of cooked food, tea and break-fast to the Jail Inmates of the Daman Sub-Jail, the EMD / SD of such tenderer will stand forfeited to the Govt. and the contract stand terminated with no further liabilities on either part to the contract.
- 20) In case of failure / rejection / termination of accepted tender, the next lowest rate offered or any other source as may be decided by the Tender Inviting Authority, the loss to the Govt. on account of such purchase shall be recovered from the former supplier's EMD / SD or bills payable. The supplier shall have no right to dispute with such procedure.
- 21) If at any time after the order placed for supply of cooked food for any reason whatsoever not required the whole or part of the quantity thereof as specified in the order, the Tender Inviting Authority shall give notice in writing to supplier. The supplier shall have no claim for compensation by reason of any alteration which shall involve any curtailment or the supply of originally contemplated.
- 22) The EMD / SD paid by the tenderer earlier against any tender or supply is / are not adjustable with EMD / SD required by these condition.
- 23) The Lunch should be supplied between 12:00 AM to 12:30 PM and Dinner should be supplied between 06:00 PM to 06:30 PM at the Daman Sub-Jail.
- 24) The morning Tea with Break-fast should be supplied between 08:30 AM to 09:00 AM and Evening Tea between 04:00 PM to 04:30 PM at the Daman Sub-Jail.
- 25) In case, any Jail Inmate is observing fast, he should be supplied food as per his demand, by observing ratio / quantity. Sick Jail Inmate should be supplied food according to the advice of Doctor, observing the ratio / quantity.
- 26) Extra charge for the special diet provided to the prisoners as directed by the Medical Officer will be paid in addition to the existing bill. The bill for the said Special Diet to be certified from the Assistant Jailor, Daman Sub-Jail for necessary payment in addition to the existing monthly bill.
- 27. On the occasion of festivals, as specified by the Govt., and on every Sunday, extra special items i.e. Sweet, Kheer, Puri etc. supplied to every Jail Inmates of the Daman Sub-Jail
- 28. The tenderer will have to remain present at the Daman Sub-Jail to supply cooked food, tea and break-fast to every Jail Inmates. The tenderer will not be allowed to sublet the contract to any other person as sub-contract.
- 29. It will be the responsibility of the tenderer to maintain the supply of cooked food, tea and break-fast on time.
- 30. The tenderer is sully responsible to provide the food at the Daman Sub-Jail from the place at which he / she prepare the food / tea / break-fast at his / her own risk and if

- supplied food / tea / break-fast found defective, the tenderer may be given punishment as per the legal provision.
- 31. The tenderer has to take care of the cooked food / tea / break-fast in quality as it directly reflects to the health of Jail Inmates.
- 32. The tenderer has to prepare Lunch, Dinner, Morning Break Fast, Tea etc as per the scale of diet schedules mentioned in Model Prison Manual 2016 in Chapter VI at Page No. 65 per prisoner per day as mentioned below:
