5. Bidders are requested to submit **Price bid (Section-V) online only** and **not to submit the Price bid in physical form**. This is mandatory. If price bid is submitted in physical form, same will not be opened and only on-line submitted price will be considered for evaluation.
6. The tender fee will not be refunded under any circumstances.
7. Earnest Money Deposit (EMD) in the form specified in Tender Document only shall be accepted.
8. If any documents are missing on required at the time of verification of the physical documents the same shall be submitted by the bidder within 15 days from the date of intimation.
9. The offer shall be valid for **two years** from the date of opening of the Technical Bid.
10. Tenders without EMD or Tender Fee or Exemption Valid Certificate for nonpayment of EMD or Tenders which do not fulfill all or any of the conditions or submitted incomplete in any respect will be rejected.
11. The award of contract shall be made to a qualified Bidder, whose responsive Tender is determined to be the lowest evaluated Tender and who meets appropriate standards of Technical and Financial resources and satisfy the Qualifying Criteria as laid in the Tender Documents.
12. Conditional Tender shall not be accepted.
13. The jurisdiction of any dispute will be with Courts situated in Daman.
