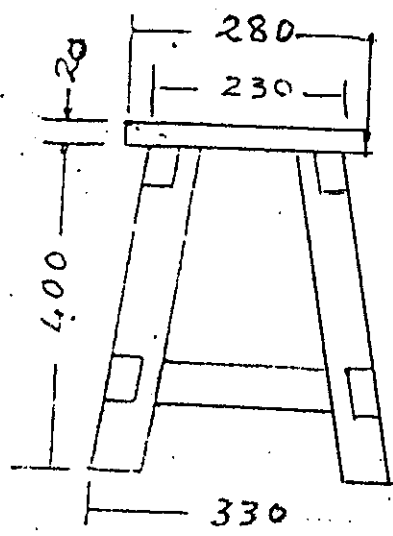
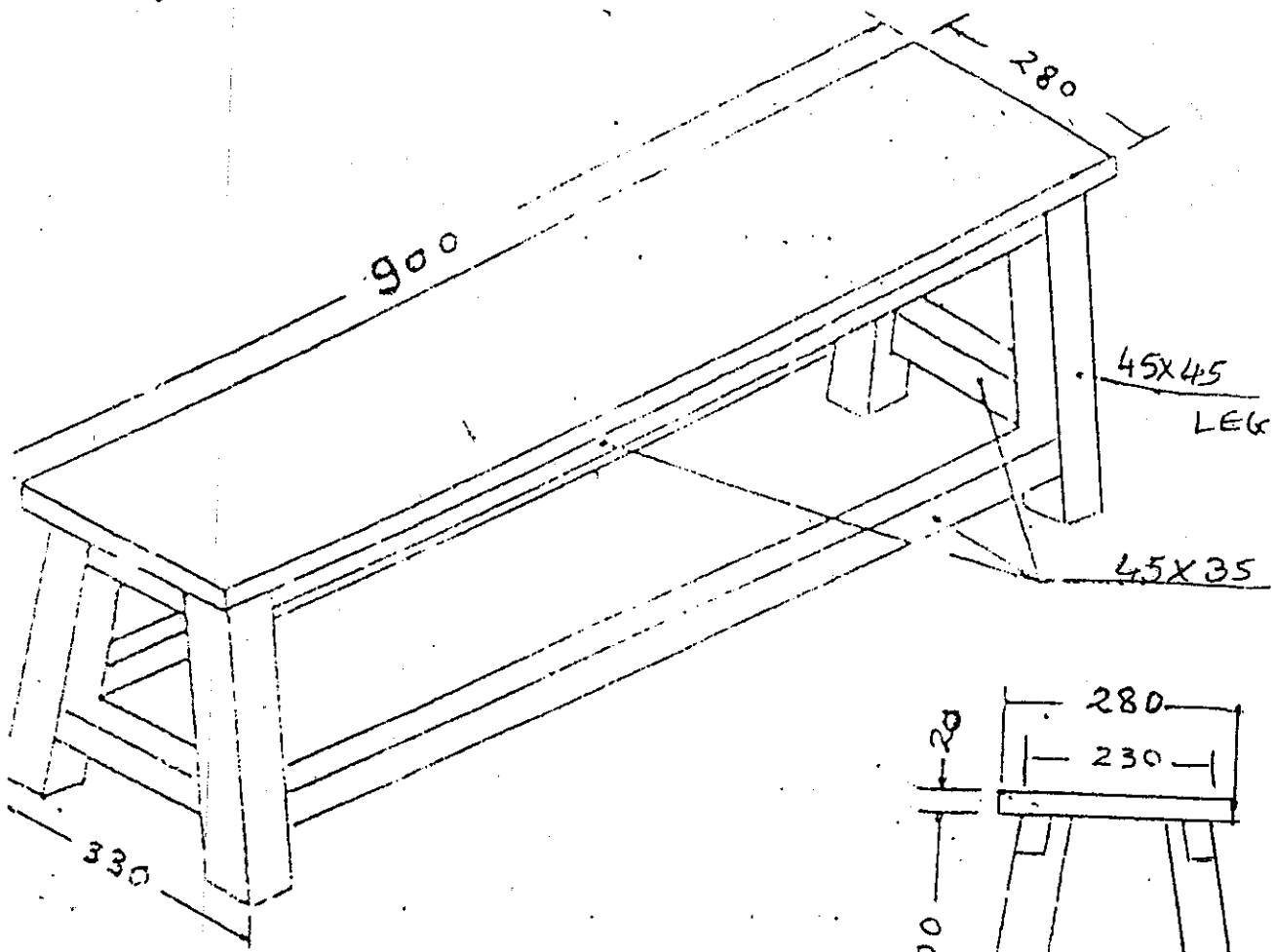
TERMS AND CONDITIONS :-

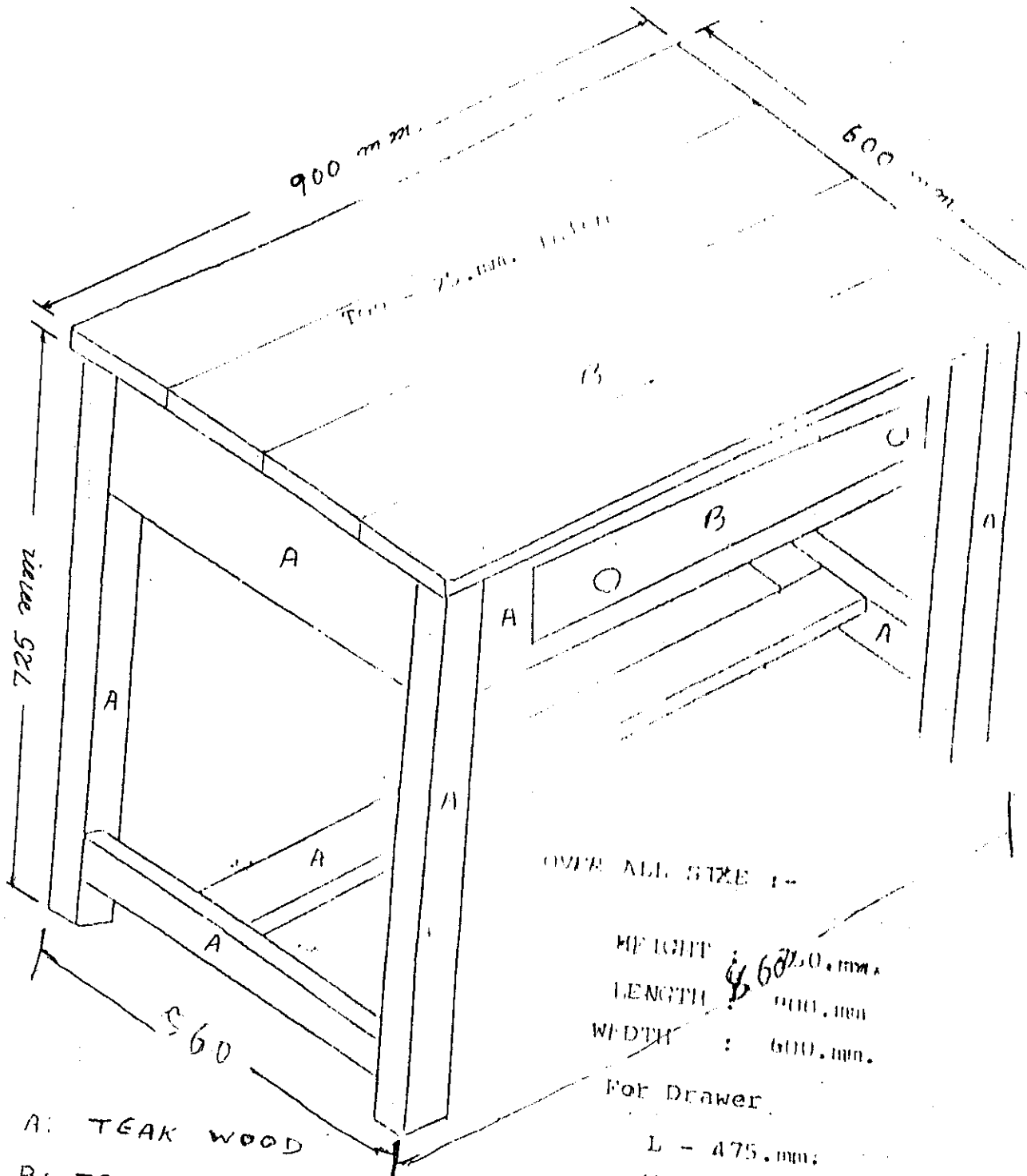

SS ROOM TABLE FOR TEACHERS



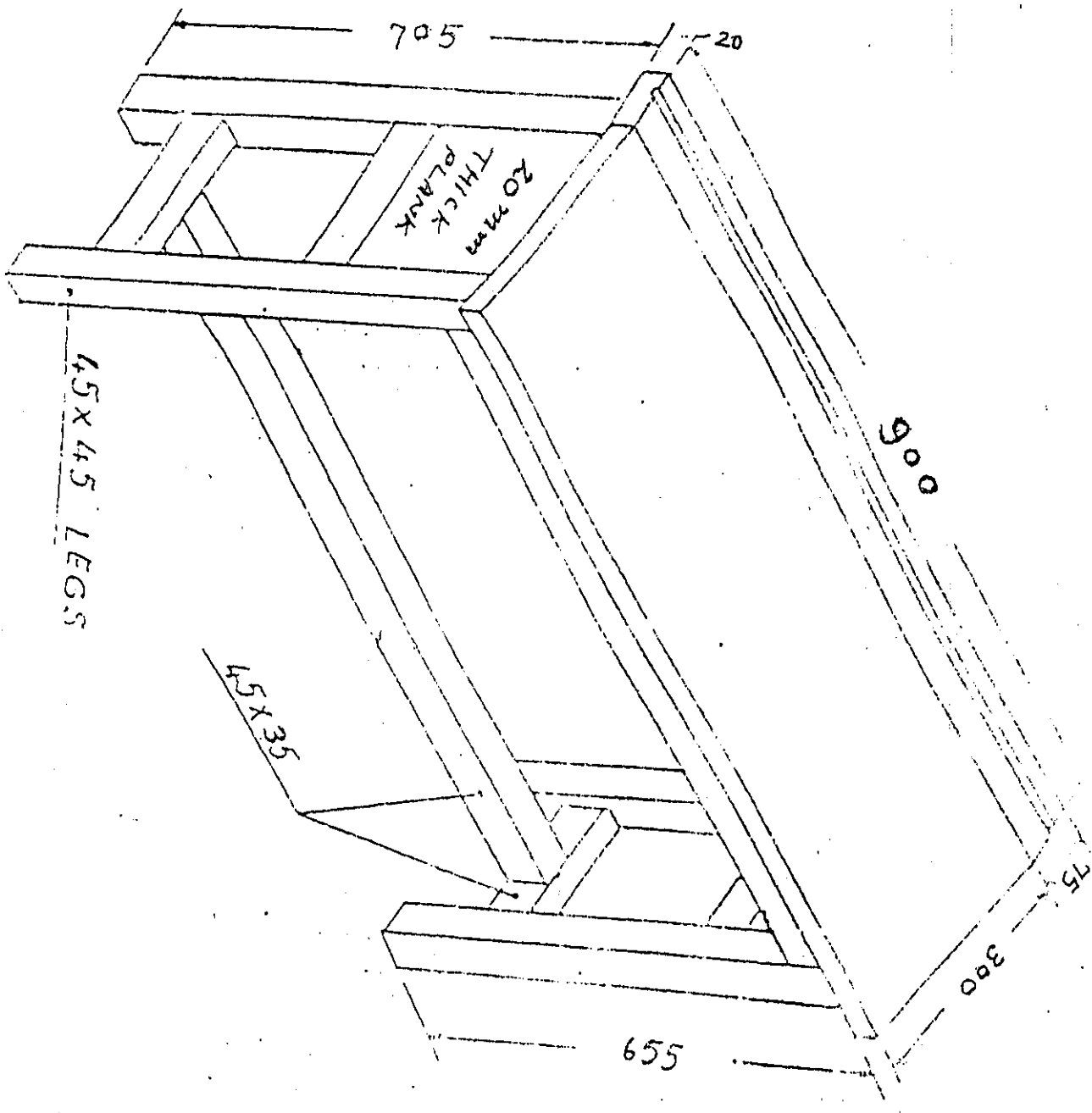
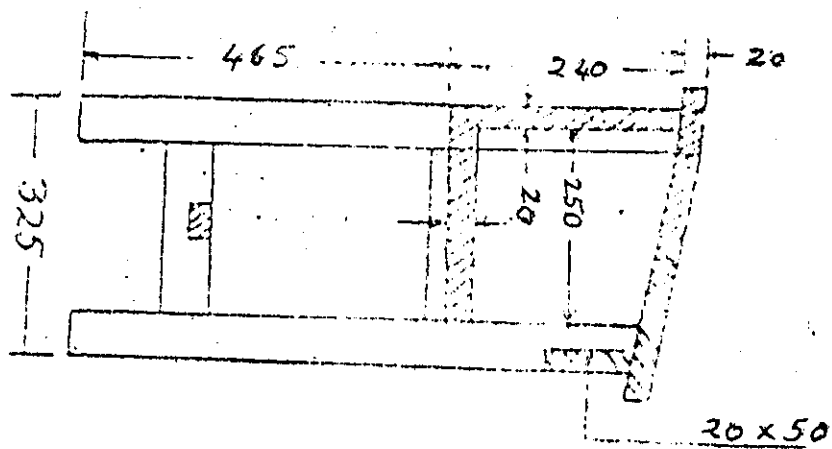
