Letter F. No. 11-18/2019-IA-III Dated 30/10/2019 received from the Joint Secretary, MoEF&CC, New Delhi requesting the Coastal Zone Management Authorities to be mindful that the CRZ map in 1:4000 scale received from the project developer shall indicate the project layout superimposed on the map. The map shall also indicate demarcation of HTL, LTL, ESA, CVCA, other regulatory lines viz. 200 m, 500 m, CRZ boundary lines in case of tidally influenced water bodies, estuaries etc. in consonance with the approved Coastal Zone Management Plan (CZMP) of the area/region.

To ensure that the project proposals received for CRZ Clearances are complete in all respect before taking up the proposal to their respective committees and subsequently furnishing their recommendations to the Ministry.

The DDCZMA noted the contentment of the letter dated 30/10/2019 from the MoEF & CC, New Delhi and decided to inform all the project proponents to submit complete file /proposal in accordance with the Letter F. No. 11-18/2019-IA-III Dated 30/10/2019

A proposal has been received from the Range Forest Officer, Daman regarding CRZ Clearance for walk in Aviary at Jampore Reserved Forest Area (Sy. No. 70 & 71 of village Jampore), Moti Daman in File No.DCF/DMN/WALK IN AVIARY/731-PART-1/2019-20/ (FTS NO: 97899).
