

M/s. Global Industries, Kachigam, Daman was issue Consent to Establish for manufacturing of "Plastic tubing, bags, rolls, sheets & shrink films (Thickness above 50 micron) – 1200 MT/Annum" under water and air act which is valid upto **28/02/2018**. The activity falls under **Category – III**.

The unit has submitted application for grant of Consent to Operate on 06/04/2017 with following documents:

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Consent fees of Rs. 3000 /-.
- Display signboard.
- Form – I for application registration under plastic waste rules.
- Form – I for application for authorization to handle Hazardous Waste.
- Industry Data Sheet Format.
- Manufacturing process.
- Declaration giving details of capital investment including land, building and plant & machinery without description.
- Copy of consent to establish obtained under water and air act.

The unit was inspected on 22/04/2017 and at the time of inspection following observations were noted:

- Display signboard was not placed at outside of premises.
- The unit was not in operation at the time of inspection.
- Machineries were not installed within the premises as per project report.

In view of above, letter to install machineries as per project report is prepared and placed in file for approval, Sir.


Letter was issued to the unit on 03/05/2017 as the unit was found closed at the time of inspection. In this regard, unit has submitted reply of above issued letter on 29/05/2017 informing that all the machineries were installed and requested to re-inspect the unit.

In this regard, the unit was inspected on 13/06/2017 in presence of Mr. Rakesh Goel (Partner) and at the time of inspection following observations were noted:

- Display signboard was installed outside of the premises.
- The unit was in operation at the time of inspection.
- Raw material used in manufacturing process was LDPE/LLDPE/LD plastic granules, and Master batch.
- Products being manufactured were Plastic tubing sheet, roll, and bags.
- Manufacturing process involved at the time of inspection was Blow film extrusion process, Cutting, Sealing and packing.
- Machineries installed within the premises of the unit were Blow film extrusion m/c – 01 nos., Winder – 01 no, Cutting and Sealing m/c – 01 nos., Cooling tower – 01 no, Compressor – 01 no.
- The generated plastic waste were stored within the premises and sold to recycler on job work bases.
- The unit was availed with Soak pit tank for disposal of domestic wastewater.

In view of the above, Consent to Operate (**Category-III**) for manufacturing of “Plastic tubings, bags, rolls, sheets, and shrink films – 1200 MT/Annum” under water act and air act, for the period up to **31/05/2018** may be issue.
