

M/s. KMG Wires Industries, Sr. no. 261/1-A (31), Ground floor, Supreme Industrial Estate, Village-Bhimipore, Daman was issued consent to establish for manufacturing of "Copper Wire-2000 MTPA, Bunched Copper Wire-1500 MTPA, Aluminium Wire and Conductor-1000 MTPA, Enamel wire-800 MTPA, PVC insulated wires and cables-1200 MTPA, Tinned Copper Wires-650 MTPA (by drawing- enamelling- PVC extrusion insulating- coating- ready for packing). (no other items)." under Water and Air act valid upto 31/05/2015. The activity falls under **Green category**.

The unit has submitted application for grant of consent to Operate under Water and Air act on 12/10/2015 along with the following documents;

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Declaration giving details of capital investment including land, building and plant & machinery without description.
- Consent fees under water and air act for Rs 4000 /-.
- Display sign board.
- Application for authorization to handle Hazardous Waste (form-I).
- Industry Data Sheet.
- Copy of Consent to Establish under Water and Air Act.

Consent fee of Rs.3672 had been accepted by PCC for period upto 30/11/2024 and remaining Rs. 328 are in deposit with PCC, Daman.

The unit was inspected on 17/12/2015 at 12:05 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was properly filled with product and waste generation details.
- The unit was in operation at the time of inspection.
- Raw materials used in manufacturing process were copper wire, bunched Copper wire, Aluminium wire and conductor, Enamel wire, tinned copper wires etc.
- Manufacturing process and machinery installed for production is same as mentioned in the submitted documents along with application for Consent.
- The unit was availed with septic tank and soak pit for domestic waste water generation.
- Housekeeping was sufficient but safety measures were not adequate as necessary.
- Proper storage facilities were available for raw material and products.
- Representative of the Unit were instructed to avail all the employees with necessary safety equipment (Head gear, gloves, goggles, safety shoes) & training related to safety precautions to reduce the risk of hazards or accidents.
- The unit is not significant to pollution potential.
