

M/s. Navjyot International Trading Pvt. Ltd., Sr. No. 145/7 & 8, Village-Dabhel, Nani Daman was issued consent to establish for manufacturing of "Soya bean Meal – 15000 MT/Annum, Soya bean Oil – 1500 MT/Annum (no other items)." under Water and Air act valid upto 31/08/2016. The activity falls under **Category-III**.

The unit has submitted application for grant of consent to Operate under Water and Air act on 09/11/2015 along with the following documents;

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Declaration giving details of capital investment including land, building and plant & machinery without description.
- Consent fees under water and air act for Rs 15,000 /-.
- Display sign board.
- Application for authorization to handle Hazardous Waste (form-I).
- Industry Data Sheet.
- Copy of Consent to Establish under Water and Air Act.

The unit was inspected on 03/12/2015 at 13:05 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was properly filled with product and waste generation details.
- The unit was not in operation at the time of inspection because unit is under trial process for regular operation of production.
- Raw material used in manufacturing process was Soya bean grains.
- Products being manufactured were Soya bean Meal and Soya bean Oil.
- Manufacturing process involved in the unit were boiling, crushing and extraction of Oil of above mentioned raw material into final products.
- Housekeeping was sufficient but safety measures were not adequate as necessary.
- Representative of the Unit were instructed to avail all the employees with necessary safety equipment (Head gear, gloves, goggles, safety shoes) & training related to safety precautions to reduce the risk of hazards or accidents.
- The unit was under renovation due to installation of machineries.
- Representative of the Unit were instructed to avail posters or stickers over each of the machine with their details and take necessary safety measures to avoid risk.
- The unit was having a D. G. Set so the representative of the unit was instructed to apply for Consent to Establish and Operate for D. G. Set and Hazardous waste Authorization within next week.
- Proper storage facilities were available for raw material and products.
- The unit is not significant to pollution potential. As there is no water used during any stage of process.

- The unit was availed with septic tank and soak pit for domestic waste water generation.

In view of the above, Operate to Consent for manufacturing of "Soya bean Meal – 15000 MT/Annum, Soya bean Oil – 1500 MT/Annum (no other items)." which falls in **Category-III** under water act and air act along with terms and conditions as mentioned in annexure-I for the period up to 30/11/2016.
