

M/s.SSF Plastics India pvt. Ltd. (Unit-III), Plot no. 29, 30 & 31, Survey no. 37/3, 37/4 & 37/5, Silver Industrial Estate, Village-Bhimpore, Daman was issued consent to establish for manufacturing of "Plastic Injection Moulded Articles and Plastic blow moulded articles-3000 MTPA. (no other items)." under Water and Air act valid upto 31/03/2016. The activity falls under **Category-III**.

The unit has submitted application for grant of consent to Operate under Water and Air act on 17/12/2015 along with the following documents;


- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Declaration giving details of capital investment including land, building and plant & machinery without description.
- Consent fees under water and air act for Rs 30000 /-.
- Display sign board.
- Application for authorization to handle Hazardous Waste (form-I).
- Industry Data Sheet.
- Copy of Consent to Establish under Water and Air Act.

The unit was inspected on 30/12/2015 at 17:05 hrs. At the time of inspection of the unit following observations were noted:


- Display sign board was properly filled with product and waste generation details but was installed inside the entrance gate of the unit instead of outside the entrance gate.
- Unit was not in operation as construction activity was under progress in the premises of the unit and machineries were not installed in unit completely.
- 3 blow moulding machine, 3 compressors, 3 chilling unit and 2 cooling tower were found installed in the unit but remaining machineries as per application for consent to establish were not yet installed.
- No raw materials and final products were found as manufacturing process not yet started due to lack of machineries and ongoing construction activity.

Based on the scrutiny of application form of Consent to Establish & Operate, Submitted consent fee and observations during inspection a quarry letter had been prepared and placed.

Unit had submitted compliance proofs against the quarry letter issued vide no: PCC/DDD/G-6080/WA/AA/BP/15-16/1323 dated 08/01/2016 on 09/02/2016.

The unit was re-inspected on 25/02/2016 at 16:30 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was properly filled with product and waste generation details.
- The unit was in operation at the time of inspection.
- Raw materials used in manufacturing process were PP, LDPE, HDPE and ABS.
- Products being manufactured during the time of inspection were blow moulded article.
- Manufacturing process used for production in the unit is blow moulding.
- Housekeeping observed was in good condition.
- Machinery installed were six blow moulding machines, two compressors, two chillers and four grinders. Representative of the unit had informed that one another blow moulding machine would to be installed within next month.
- No injection moulding machine was found in industrial premises.
- Proper storage facilities were available for raw material and products.
- The unit is not significant to pollution potential. As there is no water used during any stage of process.
- The unit was availed with septic tank and soak pit for domestic waste water generation.

In view of the above, Consent to Operate for manufacturing of "Plastic blow moulded articles-3000 MTPA. (no other items)." Which falls in **Category-III** under water act and air act along with terms and conditions as mentioned in annexure-I for the period up to 31/01/2017.
