

M/s. Soni steel and Appliances Pvt. Ltd. (Unit-II), Sr. No. 690/11 & 691/4, Plot. no. 23 & 24, Golden Industrial Estate, Somnath Road, Village-Dabhel, Nani Daman was issued consent to establish for manufacturing of "Electrical household appliances- such as Electrical Coil-CRCA strips, Electrical Stamping lamination, Mixer-Grinder, Electrical Motors, Fans, Toasters, Ovens, Hand Blenders, Vacuum Cleaners, Table top Gas Stoves, Shaft and Moulded articles – 15 Lac Pcs per ann. (injection moulding, assembling only without any pre-treatment process.) (no other items)." under Water and Air act valid upto 31/05/2016. The activity falls under **Green category**.

The unit has submitted application for grant of consent to Operate under Water and Air act on 19/10/2015 along with the following documents;

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Declaration giving details of capital investment including land, building and plant & machinery without description.
- Consent fees under water and air act for Rs 3000 /-.
- Display sign board.
- Application for authorization to handle Hazardous Waste (form-I).
- Industry Data Sheet.
- Copy of Consent to Establish under Water and Air Act.

The unit was inspected on 30/11/2015 at 10:48 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was properly filled with product and waste generation details.
- The unit was in operation at the time of inspection.
- Raw materials used in manufacturing process were ABS Plastic powder, Copper wire, polycarbonate plastic, silicon stamping set, Aluminium casting, stainless steel, MS Steel, SS Steel, rubber parts, electrical coil, heater and Master Batches.
- Products being manufactured were Electrical household appliances- such as Electrical Coil-CRCA strips, Electrical Stamping lamination, Mixer-Grinder, Electrical Motors, Fans, Toasters, Ovens, Hand Blenders, Vacuum Cleaners, Table top Gas Stoves, Shaft and Moulded articles.
- Housekeeping observed was in good condition.
- Representative of the Unit were instructed to avail all the employees with necessary safety equipment (goggles, safety shoes and fire extinguishers at necessary locations) & training related to safety precautions to reduce the risk of hazards or accidents.
- Representative of the Unit were instructed to avail posters or stickers over each of the machine with their details and take necessary safety measures to avoid risk.
- Proper storage facilities were available for raw material and products.

- The unit is not significant to pollution potential. As there is no water used during any stage of process.
- The unit was availed with septic tank and soak pit for domestic waste water generation.

In view of the above, Operate to Consent for manufacturing of "Electrical household appliances- such as Electrical Coil-CRCA strips, Electrical Stamping lamination, Mixer-Grinder, Electrical Motors, Fans, Toasters, Ovens, Hand Blenders, Vaccum Cleaners, Table top Gas Stoves, Shaft and Moulded articals – 15 Lac Pcs per ann.
