ORDER

**WHEREAS**, General Election to the House of the People, 2014, for 1- Daman & Diu Parliamentary Constituency is scheduled to be held on 20<sup>th</sup> April – 2014.

**AND WHEREAS**, I am satisfied that the adoption of immediate preventive measures are necessary for maintenance of public peace and tranquility during the period ending with date of completion of election related process.

**AND WHEREAS**, I am satisfied that there are sufficient grounds for proceeding under section 144 of the code of criminal procedure, 1973 and that circumstances do not admit of serving notices individually in due time.

**AND WHEREAS**, in exercise of the power vested in me under section 144 of the Code of Criminal Procedure, 1973, **I, VINOD P. KAVLE, DISTRICT MAGISTRATE, DIU** hereby prohibit with immediate effect till 25<sup>th</sup> May – 2014.

1. The carrying of firearms or of weapons of offences such as Lathis, Swords, daggers or Spears in any public place, street, road square, through fare, by lanes, or in any open space in the entire Diu District.
2. Use of mobile loud speakers and taking out processions between 10:00 P.M. to 6:00 A.M.
3. Conduct of public meetings and use of static loudspeakers between 10:00 P.M. to 6:00 A.M.
4. Use of mobile loudspeakers between 6:00 A.M. to 10:00 P.M. and static loudspeakers between 6:00 A.M. to 10:00 P.M. without prior permission of the District Magistrate.

**AND FURTHER** direct that the above restrictions shall not apply to public servants on duty or where prior permission in writing has been obtained from the District Magistrate.
