NOTIFICATION

In exercise of the power conferred by the proviso to article 309 of the Constitution, read with Govt. of India, Ministry of Home Affairs, Order No. 7/1/65-Est.(A) dated 16th February, 1965 and the Department of Personnel and Training O.M. No. AB-14017/61/2008-Estt(RR) dated 24th March, 2009 and in supersession of the existing recruitment rule for the posts, and all other powers enabling him in this behalf, the Administrator of Daman & Diu, hereby makes the following Rules regulating the method of recruitment to the recruitment of General Central Services, Group "A" Gazetted post of **Medical Officer (Ayurveda)** in the Directorate of Medical and Health Services, U.T. Administration of Daman and Diu, namely :-

1. Short title and commencement :

- (1) These Rules may be called the Administration of Daman and Diu, Directorate of Medical & Health Services, Group "A" Gazetted post Recruitment Rules 2011.
- (2) They shall apply to the posts specified in column-1 of the schedule to these rules.
- (3) These Rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.

2. Number of posts, Classification and Scale of Pay :

The number of the said post, its classification and scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules. Provided that the Administrator of Daman and Diu may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

3. Method of recruitment, age limit, other qualifications etc :

The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns 6 to 13 of the aforesaid schedule.

4. Disqualification :

No person, who has entered into or contracted a marriage with a person, having a spouse living, or who, having spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post : Provided that the Administrator of Daman & Diu may, if satisfied that such marriage is permissible under the personal law applicable to such person and party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax :

Where the Administrator is of the opinion that it is necessary or expedient so to do, it may, "by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving :

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backwards Classes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

NOTIFICATION

WHEREAS, vide Notification No. FSSA/DD/DMN-GUTKHA/2012-13/127 dated 11.04.2013, the manufacture, storage, distribution and sale of Gutkha and Pan Masala, containing either tobacco and/or nicotine or Magnesium Carbonate as an ingredient, by whatsoever name these are available in the market, and any other products marketed separately to constitute as Gutkha or Pan Masala, etc. as final product, was prohibited by the Commissioner Food Safety, UT of Daman and Diu, in exercise of powers conferred by clause (a) of sub section (2) of Section 30 of the Food Safety and Standards Act, 2006 (Act No. 34 of 2006) for a period of one year w.e.f. 1st May, 2013.

AND WHEREAS it is expedient in the interest of public health to extend the period of above prohibition beyond the period covered by the notification referred to above.

NOW, THEREFORE, I, the Commissioner of Food Safety, UT of Daman and Diu, in exercise of the powers conferred by clause (a) of sub section (2) Section 30 of the Food Safety and Standards Act, 2006 (Act No. 34 of 2006), in the interest of public health, hereby prohibit, the manufacture, storage, distribution or sale of Gutkha and Pan Masala, containing either tobacco and/or nicotine or Magnesium Carbonate as an ingredient, by whatsoever name these are available in the market, and any other products marketed separately to constitute as Gutkha or Pan Masala, etc. as final product, in the whole of UT of Daman and Diu, for a period of further one year with effect from 1st May, 2014.
